#### WWII POW/MIA VETERAN U.S. ARMY AIR FORCE 2<sup>ND</sup> LT. ERNEST N. VIENNEAU

On Saturday October 9th at 10:30am, in Millinocket the Nation and Maine will lay to rest a WWII POW/ MIA Veteran U.S. Army Air Force 2<sup>nd</sup> Lt. Ernest N. Vienneau that has been lost to all since 1944.

Lt. Vienneau was a co-pilot attached to the 340<sup>th</sup> Bombardment Squadron, 97 Bombardment Group, 15<sup>th</sup> Air Force, stationed in Amendola, Italy. The B-17 Flying Fortress Bomber was on a mission over Maribor, Yugoslavia when it was it by fire. Lt. Vienneau was killed instantly by shrapnel. The pilot was forced to down the plane off the coast of Vis Island, Croatia, All ten of the members of the crew survived this day. Lt. Vienneau's body was never recovered.

April 16, 2021, Lt Vienneau's remains were recovered. He will be buried with Full Military Honors with a flyover on October 9<sup>th</sup>. The American Legion Riders will escort Lt. Ernest Vienneau to his final resting place in Millinocket. American Legion Riders are asked to meet at American Legion Post 80 in Millinocket and then will go to the funeral home together for 9:45am. The funeral will be at St. Martin's Catholic Church at 10:30am.

American Legion Post 80 will hold a luncheon at the post following the burial.

"This will be an honor that we may never see again in our lifetime, to welcome home a POW/MIA" said Rick Cyr Jr. ALR Chapter 80 Director.

### EXEMPT ORGANIZATIONS E-FILE - E-POSTCARD

# What is the electronic filing requirement for small tax-exempt organizations?

**B** eginning in 2008, small tax-exempt organizations that previously were not required to file returns may be required to submit an annual electronic notice, Form 990-N, *Electronic Notice (e-Postcard) for Tax-Exempt Organizations not Required To File Form 990 or 990-EZ.* This filing requirement applies to tax periods beginning after December 31, 2006. Organizations that fail to meet their annual filing requirement for threeconsecutive years are subject to losing their tax-exempt status.

Small tax-exempt organizations, whose gross receipts are normally \$50,000 or less, are not required to file Form 990, *Return of Organization Exempt From Income Tax*, or Form 990-EZ, *Short Form Return of Organization Exempt From Income Tax*. These small tax-exempt organizations are required to file electronically the e-Postcard, Form 990-N, with the IRS annually. Exceptions to this requirement include organizations that are included in a group return, private foundations required to file Form 990-PF, and section 509(a)(3) supporting organizations required to file Form 990-EZ. In addition, this filingrequirement does not apply to churches, their integrated auxiliaries, and conventions or associations of churches.

The American Legion, Department of Maine High School Oratorical Scholarship Contest will once again be held at Thomas College in Waterville on February 12, 2022 at 9:00 a.m. Snow Date: February 19, 2022 at 9:00 a.m.

The main purpose of The American Legion Oratorical Contest "A Constitutional Speech Contest" is to develop a deeper knowledge and appreciation for the U.S. Constitution among high school students. Other objectives of the contest include the development of leadership qualities, the ability to think and speak clearly and intelligently, and the preparation for acceptance of the duties, responsibilities, the rights and privileges of American citizenship.

Young orators will have the opportunity to earn some of the most generous scholarships. At the Post and District level, scholarships offered range from \$50 - \$100, and at the State level \$50 - \$1500. At the National level, each department (state) winner who is certified and participates in the National Oratorical Contest's 1<sup>st</sup> round receives \$2,000 scholarship. Each first round winner who advances to and participates in the second round, but does not advance to the final round, will receive an additional \$2,000 scholarship to pursue education beyond high school. The overall national contest winner gets an \$25,000 scholarship. Second place takes home \$22,500, and third gets \$20,000. The members of the Oratorical Committee will be working with both Area and District Commanders to prepare Posts and Districts for their local contests. We hope to have all Post contests completed by Mid-December 2021 and all District contests completed by the end of January 2022.

The 2022 National Finals is April 22-24 in Indianapolis, at the Wyndham Indianapolis West. Quarterfinal and semifinal contests are scheduled for Saturday, April 23, with the finals scheduled for Sunday, April 24. <u>Certification of Department</u> winners is due to National by March 14, 2022.

Did you know that: The Constitution was finally ratified by all 14 States in January 1791, the last being Vermont.

Did you know that: A proposed Bill of Rights Amendment submitted in 1789 was not officially ratified until 1992 and became the 26th Amendment?

I didn't know any of these things, plus a whole lot more, until I attended our Post Oratorical Contest, the District Oratorical Contest and the State Oratorical Contest.

The students who research and present their Prepared Speech and Assigned Topics will amaze you by how much time and effort they have spent rehearsing and polishing their presentations.

I hope to see you at the Oratorical Finals, for I am sure, I will learn even more about the U.S. Constitution and the Bill of Rights again this year at the Post, District and State Finals.

- 1. Select File > New.
- 2. In the Search for Online Templates text box, type brochure, then press Enter.
- 3. Choose the style you want and select Create to download the template. The template automatically opens in a new Word document.
- 4. Select sample text in any section and enter your custom text. Replace the sample text throughout the template.
- 5. To customize the text, change the font, color, and size.
- 6. Replace the sample images, if desired. Select an image, right-click, and select Change |Image. Choose the location of the picture you want to use, navigate to the image, then select Insert.
- 7. To change the default color theme of the template, go to the Design tab.
- 8. Select the Colors drop-down arrow and choose a theme.
- Point to a theme in the Colors drop-down list to preview before applying it.
- 10. Save the changes to the brochure when you are finished customizing it. Refer to the printer documentation or manufacturer website to find instructions on how to print double-sided documents.

# **SCAM ALERT!**

If you receive this notice from "US Domain Authority", toss it in the trash!

This notice can easily be mistaken as a bill to renew your domain registration. In reality, as "US Domain Authority" makes clear on a second page, they're not domain registrars at all. Instead, they're a directory service, sort of like 20th Century phone books were directories for phone numbers. All you get for your \$289.00 is your domain name added to their directory. The disclaimer indicates on the back page, that "This is not a bill. This is a solicitation. You are under no obligation to pay the amount stated above unless you accept this offer."







# MEMBERSHIP: FREQUENTLY ASKED QUESTIONS

#### **Eligibility Questions**



Are you eligible? Here are a few trequently asked questions regarding American Legion eligibility. For any other eligibility questions, feel free to contact us at <u>membership@legion.org</u> or 317-630-1321.

# What are the eligibility dates for membership in The American Legion?

Thanks to the LEGION Act (Let Everyone Get Involved In Opportunities for National Service Act), Congress expanded the current eligibility period to cover Dec. 7, 1941, to the present, and includes the current war campaigns. Previously, there were seven declared war periods. Now there are two, the current war period dating back to World War II and another war era covering World War I. No other restrictions to American Legion membership changed.

#### I'm currently on active duty. Am I eligible?

Yes, you are a veteran. All current active duty military are eligible for membership.

# I didn't retire from the military, but was on active duty during one of the qualifying time periods. Am I eligible?

Yes, you are a veteran. As long as you have served at least one day of federal active duty during any qualifying period, you are eligible for membership.

# I served during one of the qualifying periods, but was never in a combat zone. Am I eligible?

Yes, you are a veteran. Location of active duty service is not a consideration for membership.

#### I'm currently in the National Guard/Reserve. My unit was activated under Title 10 orders during a qualifying time period. Am I eligible?

Yes, you are a veteran. Title 10 orders are issued by the Secretary of Defense and therefore are federal orders.

#### My National Guard unit was activated for crowd control under Title 32 orders during one of the qualifying periods. Am I eligible?

No. Title 32 orders are issued under a governor's authority, whereas Title 10 orders are issued from the Secretary of Defense.

# I'm currently a cadet at one of the U.S. Military Academies. Am I eligible?

Yes, you are a veteran. The American Legion has considered service in the military academies as eligible for membership since WWI.

Can I be an honorary or social member of The American Legion?

No. Per National Constitution and By-laws, no form or class of membership is authorized except regular active or paid up for life.

#### I served my entire military career in the National Guard/Reserves, and only have a DD214 from my Active Duty for Training that I was in during one of the qualifying dates. Am I eligible?

Yes, you are a veteran. In the mid-60s all basic training and occupational training schools were considered federal active duty service.

#### I served active duty as a SPAR, WAC, WASP, or WAVES during the one of the qualifying periods. Am I eligible?

Yes, you are a veteran. Even though women served separately than men, their service is equal.

#### I served with allied military forces during one of the qualifying periods. Am I eligible?

Yes, you are a veteran, only if you were a U.S. citizen at the time of entry.

#### I served with the Civil Air Patrol/Civilian Technical Corps/USPHS as a civilian during two qualifying periods. Am I eligible?

No. Eligible members must have federal military service during a qualifying period and received an honorable discharge or discharge under honorable conditions.

#### I enlisted and went to basic training, but received an uncharacterized discharge due to a medical condition. Am I eligible?

Yes, you are a veteran. Uncharacterized discharges for medical discharges are assumed to be under honorable conditions unless specifically stated otherwise. There are other categories of uncharacterized discharges and before they are determined eligible for membership the discharge should be sent to National for determination and a record will be maintained at National on final determination.

#### I'm eligible for The American Legion, but do not have a copy of my DD214 to show as proof of eligibility. How can I get one?

You can go to <u>archives.gov/veterans</u> to request another copy of your discharge papers. A copy of orders putting you on federal active duty can be used as proof of eligibility as well.


