NATIONAL ANNUAL HISTORY BOOK JUDGING CONTEST RESULTS

National Commander Dillard, national officers, National Executive Committee members, alternate National Executive Committee members and the rest of the American Legion Family. The annual history book judging for this year has been rather interesting because of the COVID pandemic and true to The American Legion spirit, we continued on with the contest with fewer judges than normal, which worked as we had fewer than normal entries.

History is an important part of our lives and as we depart these meetings and look back at what we accomplished, that is called history. The proper preserving of these meetings and events are the historian's duties and sometimes are overlooked. It is not just about taking pictures, but they are wortha thousand words.

I had the pleasure of having the Sons of The American Legion National Historian, William Townes and National Archivist Cathi Taylor from the national American Legion Auxiliary staff attend our judging of the books and attended the training along with new department historians. They said that they thought it was very useful and will pass on the training to others. I will be working with the Sonsof The American Legion national historian and the American Legion Auxiliary national historian to investigate the formation of a historical society. We will be assisting each other and helping all the post, unit, squadron, department, and detachment groups in preserving all Legion Family history.

I cannot give enough credit to Howard Trace and the library staff for all the help that they have given me since taking this office, but come to think of it, they have helped me and all the NADHAL members for as long as I have been a Legion historian. If you have questions about getting involved in the history contest, reach out to myself, your department historian, or national library staff for more information.

I know you're all wanting to know the contest results. The top five entries in the Post Yearbook category were so close, there was only five points difference between the third and fifth entries. They were all very good books.

WASHINGTON CONFERENCE CANCELED AS AN IN-PERSON EVENT

National Commander Paul Dillard has decided to cancel the Washington Conference as an in-person event. This decision was prompted by health concerns, extremely limited access to Congress, and the availability of alternative means of getting The American Legion's message to our elected representatives.

However, the National Commander will be presenting testimony to both the House and Veterans Affairs Committees on or about Wednesday, March 2nd. At this time, we do not know if the testimony will be presented virtually or in person. We do know that the Chairpersons of TAL Legislative, VE&E, VA&R, NS/FR, and Legislative Commissions will be invited to attend the testimony along with the President and Executive Director of ALA, and National Commander of the SAL/

TAL Washington-based commissions will meet virtually – more information and dates to follow.

In lieu of an in-person Washington Conference, National Commander Dillard is encouraging all American Legion, American Legion Auxiliary, and SAL members to make appointments with their members to meet in their home offices – more information to follow, along with a list of legislative concerns. There may also be a virtual "Know Before You Go," but time and date has not been decided.

TAL DSO School scheduled for DC during the first week of March has also been cancelled as an in-person event. Those scheduled to attend will receive information shortly on accessing the virtual DSO substitute meeting.

As we firm up the schedule, you will receive additional information. In the meanwhile, hang tight. Chairmen will receive a call-in communication shortly.

The American Legion, Department of Maine High School Oratorical Scholarship Contest will once again be held at Thomas College in Waterville on February 12, 2022 at 9:00 a.m. Snow Date: February 19, 2022 at 9:00 a.m.

The main purpose of The American Legion Oratorical Contest "A Constitutional Speech Contest" is to develop a deeper knowledge and appreciation for the U.S. Constitution among high school students. Other objectives of the contest include the development of leadership qualities, the ability to think and speak clearly and intelligently, and the preparation for acceptance of the duties, responsibilities, the rights and privileges of American citizenship.

Young orators will have the opportunity to earn some of the most generous scholarships. At the Post and District level, scholarships offered range from \$50 - \$100, and at the State level \$50 - \$1500. At the National level, each department (state) winner who is certified and participates in the National Oratorical Contest's 1st round receives \$2,000 scholarship. Each first round winner who advances to and participates in the second round, but does not advance to the final round, will receive an additional \$2,000 scholarship to pursue education beyond high school. The overall national contest winner gets an \$25,000 scholarship. Second place takes home \$22,500, and third gets \$20,000. The members of the Oratorical Committee will be working with both Area and District Commanders to prepare Posts and Districts for their local contests. We hope to have all Post contests completed by Mid-December 2021 and all District contests completed by the end of January 2022.

The 2022 National Finals is April 22-24 in Indianapolis, at the Wyndham Indianapolis West. Quarterfinal and semifinal contests are scheduled for Saturday, April 23, with the finals scheduled for Sunday, April 24. <u>Certification of Department</u> winners is due to National by March 14, 2022.

Did you know that: The Constitution was finally ratified by all 14 States in January 1791, the last being Vermont.

Did you know that: A proposed Bill of Rights Amendment submitted in 1789 was not officially ratified until 1992 and became the 26th Amendment?

I didn't know any of these things, plus a whole lot more, until I attended our Post Oratorical Contest, the District Oratorical Contest and the State Oratorical Contest.

The students who research and present their Prepared Speech and Assigned Topics will amaze you by how much time and effort they have spent rehearsing and polishing their presentations.

I hope to see you at the Oratorical Finals, for I am sure, I will learn even more about the U.S. Constitution and the Bill of Rights again this year at the Post, District and State Finals.

ENHANCED PENSION BENEFITS HELP ELIGIBLE WARTIME VETERANS, SURVIVING SPOUSES INCREASE INCOME

If you are a wartime Veteran who meets certain requirements, or you are a surviving spouse, then you may be eligible for VA's pension benefits. <u>VA's</u> <u>Aid and Attendance and Housebound benefits</u>, or enhanced pension, can boost your pension payments. If you need help with daily activities, or if you are housebound, you may qualify for an increased monthly pension.
