

The next assignment was at NSGA Edzell, Scotland. Halfway through his tour, is when Patricia Shahan from Los Angeles arrived for her first Naval assignment and the rest is history. The following assignments to follow were Misawa, Japan, and NSGA Pensacola, Florida. While stationed at Pensacola he was temporarily assigned to the Department of Justice (DOJ) for a six-month tour in Washington DC. Finally on the USS Hue City (CG66) as a Cryptologic Combat Support System (CCSS) Operator and Threat Analyst homeport at Mayport, Florida. His theme as national commander is "V.E.T.S., Veterans, Education, Teamwork and Sponsor."

A life member of American Legion Post 1682 in Rockland County, N.Y, he served in the U.S. Navy and Navy Reserves from 1969 to 1974. He completed a tour aboard the USS Nitro, an auxiliary ammunition ship with the Sixth Fleet. He was honorably discharged as a boatswain's mate third class. He is also a Veterans Employment and Education Squadron 1682 based on the World War II service of Jim's father.

Jim spent his entire working career in he began as a parts manager at a local Chevrolet dealership and went to serve in many capacities of management. At the time of his retirement in 2017, he was director of service and parts at a New York Metro Mercedes Benz dealership. The Be the One campaign will:

- Destignatize asking for mental health support, creating opportunities for those with mental health issues to speak freely and get the support they need.
- Provide peer-to-peer support and resources in local communities.
- Deploy FDA-approved therapeutics for veterans to identify issues and find resources for support.
- The stigma associated with mental health issues is a barrier to veterans seeking assistance.
- 2. Family members may be the first to recognize the signs that their veteran needs help, but they may lack the knowledge of how to approach the situation.
- 3. Veteran service organizations, Training, now more than ever, we like The American Legion, provide a well-established peer support network that is ready, willing, and able to help in local communities.
 - 4. The Legion is also willing to explore partnerships with other like-minded organizations where the opportunity exists to amplify and/or complement one another's strengths.



DOLITICAL ENDORSEMENTS AND DONATIONS

Maine is gearing up for another round of elections at the State level. There is some information your Post should be aware of this time of year.

Article II, Section 2, of the National Constitution of The American Legion states, "The American Legion shall be absolutely nonpolitical and shall not be used for the dissemination of partisan principles nor for the promotion of the candidacy of any person seeking public office or preferment."

The National Charter, approved by Congress, also stipulates The American Legion as an organization "is nonpolitical" which is interpreted as "nonpartisan". Therefore, The American Legion as an organization is prohibited from contributing, helping, or endorsing a candidate, and putting political signs in front of a Post. A Legion member, as a private citizen, and not representing a Post or

flags to avoid any impression of endorsements. Every candidate should be presented with an equal opportunity at the same time to use the Post facilities on the same terms and conditions.

If a Legionnaire is attending a political event, the Legion cap (the official uniform) should be removed so there is

If financial contributions are offered ethical by candidates for political office, campaigns, action committees, or political parties, The American Legion should politely decline. Accepting contributions may be legal, but The American Legion must avoid perceptions of supporting any candidates or political parties.

To be eligible under our nonprofit status, the IRS mandates the strict nonpartisanship of all such activities by organizations eligible to receive tax-deductible contributions under Section 501(c)(19) of the Code. Failure to do so could endanger an American Legion post's nonprofit status. A nonpartisan organization does not support, oppose or provide aid to any candidate for public office or to any political party. Newsletter/Newspaper/Magazine Articles

A post newspaper, or magazine article newsletter, is a means for each post in the Department of Maine to get the word out to post membership, while adding to the history of a Post. This will help keep members informed of post activities as well as important news and information from the post and the American Legion. In addition, a post newspaper or magazine article can be used within the post's community, and surrounding area, to entice public participation in activities. A newsletter is a valuable recruiting source.

I – Basic Information

A newspaper or magazine article can be written by anyone at their post and cover any topic, as it relates to the post, i. e. history, activity, event, post member spotlight, etcetera. To qualify for the Depart-

ment of Maine Post Article Contest, the article must be published in newspaper and/ or magazine in the Department of Maine "The Maine Legionnaire, Post Newsletter, or local newspaper(s). At a minimum, the article is to be one page long, not including photographs.

Use plain and unruled 8½ x 11 white and/or colored bond paper for your article. The articles should be computer generated on both sides of the paper using a printer. It is allowable to use a typewriter to produce a submission but not recommended. It is recommended that Microsoft Word be used for all typing and formatting. Margins are a must for neatness, readability, and standardization. The standard margin for articles will be one inch, all around.

Use single-spaced copy on pages with a three to six-space indention for new paragraphs and single-spaced lines for photograph identifications. If you have any doubt of the spelling of a word, use a dictionary. Also double-check the spelling of all names.

The information found in any article is another link in the permanent record of a post and its history. This outline should be followed as closely as possible. It is to the editor's advantage to check any submission against the guidelines suggested here. These guidelines will be used to score all articles submitted to the annual Department of Maine Article Contest.

The submitted article will be accompanied by the Department of Maine Submission Form, SF-01. The form must be filled out in its entirety and be submitted to the Department of Maine Adjutant and Historian. Failure to submit SF-01 will result in the disqualification of the submission. A total of 3 articles from a post can be submitted. Only one submission form needs to be submitted with the articles but

the title of each submitted article must annotated on the SF-01.

The submitted article must be submitted in the format as stated above. Any articles submitted, that are copies of any printed publication, WILL BE disqualified from the competition.

The Judging Committee will score all submissions fairly and with impartiality. If any judge on the committee has an entry in any competition, they are judging that judge cannot judge his/her own entry. Categories will be judged on whole point awards for any category.

The History and Media Committee (HMC) has developed a Department of Maine scoresheet for the Post Article Contest. Scoring will be a three-way process. The first will simply be an "eyeball" judgement in which the weaker submissions will be removed from consideration. Secondly, the remaining submissions will be looked at closer and will be scored by the category score sheet, if needed. Thirdly, if scoring is done, and there is a tie in the scoring of the submissions, the Department of Maine Historian will make the final decision for the winning submission.

II - Scoring

1) Article Title and Author Name: 5 Points - The article should have a title and the author's name. A title should be something that a reader can see what the topic of the article will be while being catchy enough to draw the viewer to read the arti-

cle. The font size used for the title should be the largest size in the article. Scoring will total forty (40) points. There is an additional five (5) bonus points that the judges can award for something original, or eye-catching, as they read the article.

2) Department of Maine Submission Form, SF-01: 1 Point

3) Article Continuity: 4 Points

- a. Fonts: 1 Point Keep the font the same throughout the article. The author may use a font color to highlight article titles and other areas of interest. Do remember that the article should look the same as it was submitted for publication to Department of Maine or local publications.
- b. Layout: 1 Point Articles should be in a single page format, not columns. It is up to the publication submitted to in deciding how they will publish the article. Keep overall continuity in mind.
- c. Content: 2 Points Content should be a topic that is relevant to the Legion and the Post. There are many topics that can be utilized within the content of a publication. Remember to tell the story of the topic.
- d. Readability: 4 Points Each article should be easy to read and easily

followed. The following categories are important in publishing a newsletter that can be easily read and followed. The article can be written in the first, if the article is from the authors point of view. The third person will be used for all other stories.

Compound sentences should not be used in the writing style. This does not mean that a two-sentence compound cannot be used, just do not overuse it. For scoring purposes, a compound sentence consists of three, or more, sentences joined in some way, such as "and," to make one sentence.

- Correct Grammar Usage: 1 Point
- Check spelling: 1 Point
- Check punctuation: 1 Point iii.
- Check that the correct acronyms are used: 1 Point
- e. Photographs: 6 Points Photographs, whether color or black and white, should be used. Blurry and fuzzy photos are a distraction and will take away from the overall continuity and readability of an article. When identifying individuals do so from left to the right. There is a total of 10 points to be awarded for this section. Identification of photos should use the following sequence of information and be consistent throughout the newsletter.

- Name(s): (Full proper name no 11. nicknames): 1 Point
 - iii. Occasion: 1 Point iv. Location: 1 Point
 - Date: 1 Point v.
- Photo Credit: 1 Point vi.
- vii. Photo Clarity: 1 Point
- f. Tie Breaker: 5 Points In the event of a tie in the article competition, the Department of Maine Historian issue a point to one of the tied articles in order to break the
- 4) Score Sheets: If an author wishes to score their own article before submission, please email the Department of Maine Historian and he/she will forward a copy of the score sheet to the requestor. Besides their use for scoring in the Post Article Contest, the annotated score sheets should be used as an education tool for each author to write an improved article for the following competition year. In addition to the plaque and Certificate of Appreciation being presented at a Maine Department Convention, a copy of the contestant's scoresheet will be included in the presentation folder.

Recently, I attended a White House signing ceremony for three bills I championed to help ensure that America's veterans receive the benefits, resources, and recognition they earned through their service to our country. It was a pleasure to witness the President sign into law two important bills that will strengthen breast cancer detection and prevention services, and one to pay tribute to the courageous Army Ranger veterans of World War II.

Women are the fastest-growing part of our veteran population. The bipartisan MAMMO for Veterans Act I co-authored will expand veterans' access to high-quality breast cancer screening and lifesaving cancer care. Specifically, the law will require the Department of Veterans Affairs to develop a strategic plan to improve breast imaging services, create a telemammography pilot program for veterans in areas where VA does not offer in-house mammography, and expand veterans' access to clinical trials through partnerships with the National Cancer Institute.

As a companion to that bill, the President also signed the SERVICE Act of 2021. This legislation expands eligibility for VA mammography screenings to veterans who served in areas associated

of a Congressional Gold Medal to World War II Army Rangers in recognition of their heroic service. Approximately 16 million Americans served in the U.S. military during that war. Among those soldiers, only 7,000 were Rangers. Of that elite group, there are now just a handful of

Those Rangers distinguished themselves in both the European and Pacific theaters. They are perhaps best known for their astonishing bravery and determination on D-Day, when they scaled the sheer 100-foot cliffs at Point du Hoc to eliminate the German threat to the amphibious landings at Omaha and Utah

living World War II Rangers left.

Six months later in the clude Thailand, Cambodia, Laos, Guam, Philippines, another Ranger battalion American Samoa, and Johnston Atoll. carried out a daring operation behind enemy lines to rescue more than 500 Allied POWs from a Japanese prison camp. That legendary special-operations unit established a legacy that continues to inspire us eight decades later.

In addition, both chambers of Congress have overwhelmingly passed historic legislation to address toxic exposure among service members. The Sergeant First Class Heath Robinson Honoring Our Promise to Address Comprehensive Toxics (PACT) Act of 2022 will ensure all generations of toxic-exposed veterans receive the health care and benefits which they have earned.

The bill is named after Sergeant First Class Heath Robinson, who deployed to Kosovo and Iraq with the Ohio National Guard. Tragically, he died in 2020 from toxic exposure as a result of his military service. Among its many priorities, the PACT Act will expand VA health care eligibility to Post-9/11 combat veterans, toxic-exposed veterans. It will add 23 burn pit and toxic exposure-related conditions to VA's list of service presumptions, and it will expand presumptions related to Agent Orange exposure to in-

Additionally, it will strengthen federal research on toxic exposure, improve VA's resources for toxic-exposed veterans, and expand training for VA health care and benefits professionals.

The brave men and women who have served in our military put themselves in harm's way, and it is our responsibility to provide them with the highest quality health care for any illnesses linked to their military service. For far too long, veterans exposed to toxic substances such as Agent Orange and burn pits during their deployments have not received the recognition or resources they needed. This comprehensive legislation puts us on the path to fulfilling the enormous debt we owe these veterans by expanding critical research on toxic exposure and providing relief to toxic-exposed veterans who may be experiencing serious illnesses and debilitating symptoms.

Our nation has a duty to honor the which includes more than 3.5 million courage and sacrifices of those who serve, not just with words, but also with actions. As a Senator and the grateful daughter of a veteran, I am committed to ensuring that the government keeps that sacred obligation.

trict reps to help push the bill through. It is now waiting to go to the President's desk for signature. A big thank you to all who assisted in this. The benefits of the bill are too many to mention so I will just list a few. It allows presumptive service connection for those who served in Thailand, Guam, and other places in Southeast Asia for Agent Orange exposure. It also increases medical coverage for 911 veterans from 5 to 10 years.

There have been three conditions that have been added to the presumptive condition list for agent orange exposure. They are Bladder Cancer, Hypothyroidism, and Parkinsonism.

The VA also added three conditions to the presumptive condition list for Veterans that served in the Southwest Asia theater of operations during the Persian Gulf War, and/or Afghanistan and Uzbekistan after September 19, 2001. The Southwest Asia theater of operations refers to Iraq, Kuwait, Saudi Arabia, the neutral zone between Iraq and Saudi Arabia, Bahrain, Qatar, the United Arab Emirates, Oman, the Gulf of Aden, the Gulf of Oman, the Persian Gulf, the Arabian Sea, the Red Sea, and the airspace above these locations. Those conditions are Asthma, rhinitis, and sinusitis.

The last change I want to highlight is to the motor vehicle excise tax exemption for those veterans who are 100% permanent and total disabled through the VA. The entitlement is for one vehicle per year. Please stop by your local town hall for additional information.

In the last article, I talked about the problem with the contracted companies that are handling most of the compensation and pension exams for the VA. As an update, I can tell you that the situation is improving. That does not mean that the system is running smoothly. It means that the delay is less than it was and that I am hearing less from veterans that they are told to leave the state of Maine for an exam. If you come across a veteran that was told he must travel outside the state for an exam, please let me know.

APPEALS OF CLAIMS. The appeals process is no longer the strict

structure it was. If your decision was after the 19th of February, you fall under the AMA. There are now five lanes you can choose from. The first two are at the regional level. Sign up for VA Healthcare. Signup for VA Healthcare can now be done three ways! The Department of Veterans Affairs (VA) announced today it has eliminated paper signature requirements for veterans wishing to enroll in VA health care. Effective immediately, VA has amended its enrollment regulations to allow veterans to complete enrollment applications for enrollment in VA health care by telephone without the need for a paper signature.

By adding this telephone application option to VA's regulations with this amendment, VA will now offer three ways to enroll. This option provides Veterans a convenient third enrollment option.

Preventing VA Closures in Rural Maine "BE THE ONE" and Across the Country

Thether veterans live in a city or a to these facilities Maine veterans rely on rural community, we have a duty

Maine Veterans Homes facilities in Caribou and Machias nearly closed before the state legislature was forced to step in. And in March, bureaucrats in Washington quietly recommended closing VA facilities in rural communities across the country, including three here in our state.

What's the story on these recommendations? In 2018, before I was elected, Congress passed a bill that created a panel called the Asset and Infrastructure (AIR) Commission and tasked it with processing recommendations to 'streamline' VA facilities. We found out a few months ago that those recommendations include the proposed closure of the CBOCs in Houlton, Fort Kent, and Rumford, and the closures of the emergency department and community and residential care programs at Togus.

Closing these facilities would put health care further out of reach for many Maine veterans, forcing them to drive even further than they already do for VA care. We can't let that happen.

To prevent these closures, I have been working across the aisle with a representative from West Virginia to introduce a bipartisan bill that will eliminate the AIR commission and the threat that it posed for health care.

I know that Mainers are dedicated to supporting our veterans and that they do not want Congress to reduce access to health care for veterans. I have heard from veterans' organizations across the state, including the American Legion, about the impact these closures would

I'm committed to continue working with my colleagues on both sides of the aisle to stop this failure of veteran care before it



Edward Lopeman: 1895-1918 Our Proud Namesake From the Great War

ton, Maine on September 16, 1895, the third of nine children of William and Rose (Douglass) Lopeman. Edward's father William was born in St. John, New Brunswick, the son of Irish immigrants. His mother's side was deeply rooted in West Bridgton.

Edward's Uncle, Samuel Douglass, served as a wagoner in Georgia during the Spanish American War. His maternal grandfather Daniel Hill Douglass fought in Company G, 11th Maine Infantry

dward Lopeman was born in Bridg- he was wounded. As far back as the birth of our free nation, Edward Lopeman had ancestors who bore arms for the United States. His great, great grandfather John Douglass was a Revolutionary War veteran, serving in the 13th Massachusetts Infantry from 1779-1782.

> Edward himself continued his maternal family's tradition of military service. He enlisted at Norway, Maine to serve with Company D, Second Maine Infantry Regiment, on June 21, 1916.

He served four months of active duty during the Civil War, during which time on the Mexican border at Laredo, Texas, remained with his National Guard outfit long enough to be ordered again to active duty, once the United States entered company first served at Saco, shortly after it joined the 103rd Infantry Regiment. On May 4, he was promoted to private first class. After a few months stateside, of the 26th "Yankee" Division, which and pushes, over a century later. were some of the first American soldiers to reach the frontlines.

Edward served gallantly during the next nine months. While fighting near Champagne-Marne, he was gassed near Saint Agnant. He was sent to the hospital, and recovered in time to join his unit for the Battle of Aisne-Marne. Unfortunately, on July 20, 1918, Private First Class Lopeman was killed in action, and made the ultimate sacrifice for his country. He was initially buried in France, but in 1921 his remains were brought back to his native Maine. Now, Edward Lopeman is buried with his parents and siblings in Forest Hill Cemetery, Bridgton, Maine.



social organization, or a Nation, whether great or small, finds it necessary to wage war, for whatever reason, it invariably entails the expenditure through sacrifice of that element of its future hopes, i.e. youths, usually between the ages of 18 through 25. Whatever the outcome of the conflict, whether in victory or defeat, those that perished in the name of their fellow citizens are in some token reverently remembered. Such remembrance may be expressed by a simple pillar, tablet, effigy of a leading commander or outstanding noble warrior, or some object like an arch or obelisk. In the history of mankind, it has been most unusual to remember participating martial individuals styled the common man or woman. Such a group commemorative may have begun in Scotland when clans fielded their fighting contingents. Each combatant as he sallied forth from his Clan territory, picked up a stone and placed it in his haversack. Those returning from the fight deposited their stones in a pile. Knowing how many had left to confront the enemy, and how many stones were counted when they returned, the Clan knew how many they had lost in the fight, and the pile remained to remind them of their sacrifice.

Fast forward to June 17, 1775, at Charlestown, opposite Boston, at a place later called Bunker Hill, although the actual battle fought there was on Breed's Hill. A new people on the Earth, who called themselves Americans, mostly of European stock, though not all, adhering to the tenets of the Church of England, though not all, agreed on one principle for which they fought: that all individuals among them had worth, and that each possessed rights that not even a monarch could abridge. On the one side, the monarch's hosts of well equipped, trained, and disciplined soldiers, considered to be the best in the world, attacked citizen soldiers, whom they considered a worthless rabble.

Crossing the Inner Harbor, the British line formed up at the base of the hill, and they advanced, confident that they would inflict a decisive victory in short order. Twice their line was repelled with heavy casualties. Taking off their back packs, in the hot afternoon they attacked for a third time. The Americans, in the redoubt they had dug the night before, possessed cartridge boxes that could hold up to 26 rounds. Each man, however, had been issued only 15 rounds, as that was all that was available at the time. By the third British assault, the valiant defenders were down to two or three rounds. It was then Prescott issued the order, "Don't fire until you see the whites of their eyes."

Finally, the Americans were pushed out of their fortified position. It was then that incredibly lucky because when a conthey suffered the majority of their casu-

henever a people, no matter their alties as they fell back on the true Bunker Hill. The Rebel rabble host suffered about 400 casualties, killed and wounded. The victorious British had over 1,000 such casualties inflicted upon them.

Returning to the point -- when each side reported what the cost of the battle was to themselves, the Americans reported every man affected, from private to Major General Joseph Warren. The British listed every officer killed and wounded, noting which noble or otherwise elite family had spawned them, and ended with: "and also killed or wounded were 905 sergeants and other ranks." The American tradition of recognizing that every life sacrificed has value was thus born.

In that tradition, eleven years ago, in the mountain village of Bethel Maine, a small group of veterans, all members of the American Legion Family, of the local Mundt-Allen Post 81, and neighboring Jackson-Silver Post 68 in Locke Mills, with other interested parties, met to discuss the concept of creating a veterans monument listing the names of all from Bethel Village, Albany, Grafton and Mason Townships, and Riley Plantation, who had served in conflicts beginning with the American Revolution up to the present.

Starting with nothing but a concept, it seemed an insurmountable task. According to the present Secretary/Treasurer of the Veterans Honor Roll Park Committee, Jane Ryerson, in the ensuing years, the Village of Bethel purchased the land adjacent to that of their Civil War Commemorative Statue, contractors donated labor and materials, ordinary citizens contributed funds, and the Collette Monument Company created the uniquely original concept that came to be adopted.

Treasurer Jane Ryerson opened ceremonies and later presented the dedication narrative.

Ryerson articulated in her dedication speech the magnitude of the project: September 27, 2011, we received our first \$100.00 donation. It was a start. After we had a new design from Collette's we had a new cost of the project. We would need a quarter of a million dollars. Imagine, \$250,000 to fund this. Sounds staggering? It did to us too. We had to be prepared to raise the full amount to pay for that their commander, Colonel William everything as you see it here today. What we did not know at that time is how much the local contractor donations would do for our fundraising goal. We were lucky,

tractor received a request to say deliver materials to the site i.e., loam, sand, rock etc., when they knew it was for this project, they donated the materials without question. This helped immensely on our fundraising figures for items that needed to be purchased.

And then there was the research of authenticating the names inscribed on the monument walls. Ryerson continued: Countless time and energy went into this project. Over 40,000 + hours by committee members alone. So much research was done. Acquisition of names itself was the largest time consumer. Not an easy task. Numerous trips to the Maine Archives in Augusta, trips to every cemetery in the five towns and others, Civil war books, research American Legion Rosters, find a grave website, old newspapers my grandmother kept, DD214's, picking local historians' brains; hours and hours and hours was spent looking up sites on the computer; any and every resource we found we used to acquire the names and verified them as we could.

The site chosen had formerly erected on it a WWII monument that Ryerson described: Once there was a wooden honor roll on this spot that held the names of local soldiers of WW II. At some point that honor roll was removed. The committee wanted to make sure that all of those veterans on that original roll of honor would be on this honor roll here today, as well as all of those who served prior and after WW II.

What you see here today is not a memorial. This is an honor roll. The difference is: A memorial pays tribute to those who have died in the service of their country. An honor roll honors all service members who have served, whether they may be living or deceased. The names engraved into this honor roll are men & women who resided in the towns of Albany, Bethel, Grafton, Mason, and Riley and were so when they either went in from these towns or were honorably discharged back to these towns upon the end of their service requirement. These veterans from these towns, made it possible for others to be able to live here in freedom.



have undeniably resulted in those of us here today enjoying the peaceful prosperity of our little corner of the world where we congregate this very moment, while others halfway around the globe combat invading armies and struggle to endure.

Since the war of 1812 the United States has never suffered a sustained occupation by a foreign army because of the Soldiers, Sailors, Airmen and Marines whose names are chiseled on this wall, as well as those on a thousand others across the nation from Deluth, Minnesota to Corpus Christi, Texas and from Honolulu to Holton, Maine. The visits of many to this hallowed place will reveal ancestral names and, like me, they will nostalgically reminisce of several generations of family, including our own siblings. Perhaps their minds, like my own, will drift to the back side of the monument. There are places for hundreds of additional names to be engraved. To sustain the peace and freedom to which we have become accustomed these spaces will be filled with names of Bethel's sons and daughters in the decades to come.

As a father having viewed the ills of battle and the sad conditions of war-torn regions, I pray no others will ever have to share in that knowledge. But with the events of Kabul less than a year behind us, none can deny the cold realities of the world. Unfortunately, tyrants exist, and the injustices of the world must be vanquished, as the courageous people of Ukraine can attest. And so, more names will inevitably be added to this monument so long as we are to live in this peaceful mountain hamlet, enjoying the fruits of freedom.

In addition to dedicating this monu-

ment, we also gather to observe Memorial Day, the appointed day for honoring our war dead. Many will visit cemeteries across the country on this day. Even my family will find its way to the East Bethel Cemetery and as I have for years, will briefly attend the grave of Sergeant Isaac W. Estes, a member of the famed 20th Maine Regiment, wounded on July 4, 1863 at the Battle of Gettysburg. Despite the victory earned on the battlefield he later succumbed to his wounds. Tragedy was compounded for his family for within a year both his wife, Nancy, and his only child, Emma, also perished. These remarks today fulfill a personal vow to Sergeant Estes, as well as my conscience, to keep his families' story of sacrifice alive a little longer.

I know that as I leave here today, heading out to enjoy time with family and friends, Sergeant Estes played a small role in giving me that opportunity, as have all the others on this honor roll. So I beseech thee to remember the sacrifice, and sometimes sadness, that gave us need for this monument, but also to ask that we take time to indulge in the joys afforded to us by so many who came before. I always had the feeling that if Sergeant Estes knew that I remembered him, he would appreciate it, but would also want me to enjoy life and not wallow in the darkness of his losses.

May we go forward in a spirit of gratitude for the bounty bequeathed to us by the sacrifices of others, when opportunity presents honor those who gave the last full measure of devotion, and pray for tranquil times for those who will one day stand their watch on the wall of freedom earning their place on these stones.

Atwood Young – A Memorial at Last

Pvt. Atwood Young, of South Paris, Young McAlister, who passed in 2000. Maine, was at last remembered 159 The dedication of Atwood's mark years after he gave the last full measure on April 30, 2022, by Posts 58 and 68, of devotion on Morris Island, South Carolina. He served in the 9th Maine Infantry Regiment, X Corps, in the fighting that continued in the weeks following the Civil War Battle of Fort Wagner, immortalized by the 54th Massachusetts Infantry. Young suffered a head wound on August 11, 1863, which was subsequently documented by Darius Shepard, a member of his unit. Buried in a mass grave on a nearby beach, his remains, along with all the others buried on the beach, was disinterred and reburied at the Beaufort National Cemetery in South Carolina. It is believed that many of the bodies burin coastal storms. In any case, if any remained, they could not be identified.

With no body to bring back home, his great-great grandson Jamison McAlister, a member of John D. Long Post 58, and his brother, Philip, Jr., applied to and received a gravestone that they could place in the family farm cemetery plot in North Esther Thurlow (1822 – 1880) became Buckfield. The dedication of Atwood's marker was something of a media event. A fullpage article appeared in the Sun Journal newspapers on May 12th, and in other area publications. ABC affiliate WMTW, Channel 8, devoted a detailed segment in their weekly Sunday Total Maine pro-

Atwood's marker records a detail of his life that he himself fabricated -- his birth year. He enlisted on September 21, 1861, claiming to have been born in 1825, when in fact, his birth year was 1812. He told a fib about his age because he felt he would be rejected from serving were he to be truthful. He had previously served ied in Beaufort were later washed away in the Maine State Militia in 1840 during the Aroostook War as the border between Canada and the United States was resolved diplomatically. This was the best war the US never fought, as not a shot was fired, and no one was injured.





The main purpose of The American Legion Oratorical Contest "A Constitutional Speech Contest" is to develop a deeper knowledge and appreciation for the U.S. Constitution among high school students. Other objectives of the contest include the development of leadership qualities, the ability to think and speak clearly and intelligently, and the preparation for acceptance of the duties, responsibilities, the rights and privileges of American citizenship.

Young orators will have the opportunity to earn some of the most generous scholarships. At the Post and District level, scholarships offered range from \$50 - \$100, and at the State level \$50 - \$1500. At the National level, each department (state) winner who is certified and participates in the National Oratorical Contest's 1st round receives \$2,000 scholarship.
