

year for our great organization. It is really appreciated by many. As I have said many times in the past, we are ordinary people doing and completing extraordinary things.

This past weekend, specifically January 14, in Brewer at our Mid-Winter Conference, we heard many great reports and had some great speakers and/ or presenters. The conference was well attended by our members. One of the speakers was the Northeast Region National Vice Commander Paul M. Kennedy from the State of Pennsylvania. He reaffirmed what we have been doing in the state with our programs and said there isn't anything I can recommend for the department to work on as you are already doing what I would normally talk about. You are to be commended. Paul also requested that I relay to you all that he was very impressed with our hospitality this weekend and that he enjoyed visiting our department.

I gave a report on the National Executive Committee and the Fall Meetings in Indianapolis this past October. We reviewed 26 various resolutions with

25 being passed and 1 rejected. We also heard reports from the chairmen of the various commissions such as the Marketing Commission, Finance Commission, Convention Commission, and Legislative Commission. We also heard a report from the Ad Hoc Committee to study membership processing during the 2022-2023 year.

Also reviewed were reports pertaining to the Sons of the American Legion regarding the Constitution and Bylaws and other matters pertaining to them.

The NEC also reviewed the confirmation of the National Commanders' interim appointments as well as the confirmation and/or cancellation of post and squadron charters. Finally, the NEC confirmed the dates of future meetings as well as significant gifts to the Legion Library.

The National Executive Committee is scheduled to meet, at a minimum, four times a year, in the spring generally in May, pre-national convention, post-national convention, and in the fall, usually in October. We are also subject to meet on an emergent or as necessary situation arises. Each Department of The American Legion has one NEC and one Alternate NEC member. The NEC also has the Past National Commanders as members with a voice but no vote. The alternates have a voice and vote if the NEC him/herself is absent. As the Department Executive Committee (DEC) is to each department the National Executive Committee is to the national organization.

report. Annual Post Data Report – This form shows all post information currently on file at National and Department HQ. Please review and make any necessary changes or corrections and submit them to Department HQ. The due date for this form will be included in the letter that accompanies it. Reminder: the Annual Post Data Report is not available online.

Consolidated Post Report (CPR) -There are two ways to submit this form. You can go to the website myl-egion. org or submit by mail using the pa-per form which can also be found on the Department website. This report is due at National July 1st, if mailed it is due to Department by May 29th. The following is information shared on the first page that explains the CPR. "The CPR may be the most beneficial document the post will complete. The post's information, combined with that of other posts, is used when the National Commander and others testify on Capitol Hill as mandated by our federal charter. Each post has a story to tell and when we speak collectively our strength is magnified". If you are submitting online, please remember you can add info and save it as you do things throughout the year. You will then be very ready to hit the submit button before the deadline.

Notification of Post/Squadron Commanders & Adjutants Form – Submit as

soon as new officers are elected for the current year but no later than July 1st. The Post Adjutant is to complete the form and submit it to Department even if the Post does not have a Squadron. This report can be found on the Department website.

Post Officers Form – This form must be filled out even if there are no changes from the previous year. This form is due to Department by July 1st. The District Officers Form is to be filled out by the District Adjutant and submitted even if there are no changes from the previous year. This form is also due as soon as new officers are elected or to Department by July 1st.

The last three reports mentioned can be found on the Department's website at www.mainelegion.org under FORMS/APPLICATIONS. Remember, all of the above-mentioned reports need to be submitted each year even if there are no changes. These reports are important. The information contained in them goes into updating the Department Directory and mylegion.org.

I won't repeat the information in the award manual, but I will say this. There are people at your Post and District level who shine every day. Working and doing the workload of many. Do them a favor, find an award that fits their hard work, and submit them for an award. It seriously does not take long to do this. Let them know what they do has meaning.

I look forward to seeing those out and about at upcoming events.

& state level. I know it has been a rough couple of years and some of our posts have struggled to get ahead of many issues related to Covid. On the other hand, many have adapted and overcome these obstacles and have set the bar even higher than before.

We started off the 2023 year with the Winter Conference scheduled for January 14th at Jeff's Catering & Event Center in Brewer. We arrived at the Center to set up for Saturday morning in a parking lot covered with snow & ice. It took the team about 1 ½ hours and we were ready. Saturday morning, I arrived at the Center and the weather was not getting any better. The Legion and the Auxiliary rooms were set up for 50 people each and I did not think we would get that many. I also received a call from the county (17th District) that it was snowing heavily with over a foot on the ground and still coming down. As the Department Officers came to me wondering about the turnout, we still had 30 minutes before we started, and I told them we would know soon. Then it happened! We had to bring in more tables and chairs with no end in sight! Between the Legion, Auxiliary, and the Sons of The American Legion, we had over 175 in attendance! The atmosphere inside was incredible and the attitudes of all present were heartwarming. The Legion Family had arrived to conduct business and not even the weather could hold us back.

Opening this Conference was our own Past National Commander Tony Jordan who seems to get everyone pumped up for the day's events. The normal business

of the Legion went smoothly as all our programs were reviewed and discussed for the new year. The Oratorical Chairperson, Maureen Malley, Baseball Chair Jeff Sukeforth, and the Director of Dirigo State Jason Hall, started the morning off, followed by Law & Order Chair Ethan McKenny, and "Buddy Checks" and membership by Vice Commander Al McKay. Vice Commander Tricia Thurston explained the importance of the paperwork and our own NEC Lloyd Woods gave us updates on resolutions at National HQ. NECA Matt Jabaut spoke on Legislative issues. Our first Guest Speaker, Dr. Ruth Moore (who is also a Legionnaire) spoke to a full house on the effects of depression, loneliness, and other causes of suicide. There was a constant engagement of questions between the attendees and Dr. Moore for the entire presentation. The presentation was well received as it will be an important issue with the "BE THE ONE" program to bring awareness to end the veteran suicide rate in this country. Thank You, Dr. Ruth Moore.

As the morning came to an end our NECA Matt Jabaut took to the podium and called up the State Commander, Kirk Thurston, and spoke about the Commander's project, Operation Reboot Outdoors. He then presented him with a Grant from Operation Comfort Warrior worth \$43,000 for his project! The Commander was speechless and those in attendance could not believe what had just happened. I think I saw a tear or two from our Commander, and definitely from his Vice Commander and wife!

After lunch, our next guest speaker was Christy Gardiner to talk about Mission Working Dogs. She spoke about the challenges in life that she had to overcome while serving our country and how she has taken that energy to a new level to assist other veterans working with her dogs. She had 2 of her dogs present and talked about the difference between Service Animals and Emotional Support Animals, and how she works to match up the dog with the veteran in need. Again, the interaction between her and those in attendance was exceptional. She is currently based in Oxford with plans on going

id-Winter Conference was a huge **IVI** success. Thanks for joining us and it was great to see all of you.

Though the conference information provided was valuable, my favorite portion was Christy Gardner speaking. She touched on her military career, her life-altering accident, and her new non-profit Mission Working Dogs.

I am a little biased, Christy and I both grew up in Auburn a decade-plus apart. I have seen her in action, read all the news articles on her, ran into her at events, and was super excited to hear she was coming.

Christy showed a slide that intrigued me, it showed the types of service dogs in Maine. She also touched on a few laws and discussed certified animals. I wanted to share a little information about service dog laws in Maine.

There are multiple laws that govern the use of service dogs; specially trained dogs that are used by people with disabilities. One of these is the ADA (Americans with Disabilities Act). The ADA is a federal law, so the basic laws for service dogs are the same for all states.

However, to make things more confusing, each state may or may not also have additional - or their own - service dog laws.

Let's define Maine's service animal definition: A Service Animal is a dog that has been deemed necessary by a doctor, psychologist, physician's assistant, nurse, or licensed social worker for someone living with a disability. The animal helps to mitigate the effects of a person's physical or mental disability. Or, a service animal is a dog that has been individually trained to benefit a person who lives with a physical or mental disability, by doing work or performing certain tasks.

Examples of that type of work:

- · Guiding someone who is blind or can't see well
- · Alerting someone who is deaf or hard of hearing to sounds or intruders
 - Providing reasonable protection
 - Pulling a wheelchair
 - Grabbing dropped items
 - Assisting someone during a seizure
- Providing physical support and/or balance and stability

service dog as an aid that helps someone with a disability to better access services, much like a wheelchair or cane. Service animals are not pets.

ADA's definition of service animals: A Service Animal must be a dog that has been individually trained for a person living with a disability, to do work or perform tasks. The work or task(s) that the dog performs must directly relate to the person's disability.

Places of public accommodation in Maine are known as PAs. The Act reto allow the use of service animals by people who are living with disabilities.

There are a few exceptions. But generally speaking, the law is one of inclusion and requires that PAs allow the use of service animals at their premises, facilities, or place of business. Examples of PAs in Maine are:

- State or town buildings
- State or town agencies
- Professional offices
- Movie theatres
- Grocery stores
- Other stores
- Public and private schools
- Trains and other types of transpor-
- Airplanes
- Hotels and motels and other places of lodging
- Hospitals
- Restaurants

When someone enters your PA and you are curious if it is a legit service dog, there are only two questions you can ask:

1. Is the animal required because of a disability?

People living with disabilities must be allowed in with service dogs and offered the same as others in public:

- Not be put in separate or designated

There are also situations when you can ask the service dog to leave:

- If the service animal is out of control and the handler does not take effective means to control it

In cases where a service dog has been excluded, the business, entity, or another place of public accommodation (PA)

a chance to use the facility or receive the goods, services, or other benefits without the dog being there. In other words, excluding the dog does not automatically exclude the person.

Service animals must generally be on a halter, tether, or leash as means of control, unless, due to the nature of the disability, or the nature of the work that the dog needs to do, prevents this.

It a halter, tether, or leash is not possible, then the service animal must still be under the control of the handler via voice, signals, or another method.



for a press release to promote your event. Download the Word document, (https:// www.legion.org/betheone/257987/beone-sample-press-release) update it with your specific event information, and distribute it to local media, community partners, and others.

• Wallet cards: A collection of printable business-card sized with Be the One branding and QR codes. They can be used as single-sided cards, combined with double-sided cards, or added to the back side of a personal business card.

It is that time of year, elections are held at Posts and Districts. Remember to elect people that are qualified to fill the position. Try not to just fill the postilion with a warm body. This does not always work. Once elections are held and installation is completed, fill out the Post or District Officer's Form and send to Department. These forms are very important to keep the Department's Directory updated. You have elected these officers, now it is so important to support them by attending meetings. Post and Districts throughout the Department are having a hard time holding meetings due to no quorum. Communication up and down the chain of command is so important. Keep the meetings informative and interesting. Try to keep the meeting to one hour. Have a copy of the meeting agenda for each member in attendance.

The following was in the previous Maine Legionnaire, but bears repeating:

District Commanders; remember you are the first line of defense against troubled Posts. During your Post visits use the Post Audit as a tool and sit with the Post Officers before or after their meeting to discuss the audit. This tool will help you identify problems/issues occurring at the Post and help create a path to correct those issues. Usually, by the time Department hears about a Post in trouble, it is too late. Revitalization needs to happen as soon as possible. More and more Posts, for some reason, think they can sell their Post and the last member standing gets the rest. Not so, refer to the Department's Constitution & By-Laws for guidelines as follows:

Commander Troiola's theme is V.E.T.S., Veterans, Education, Teamwork, and Sponsor." He talked about staying informed with legislative issues by signing up for alerts through the American Legion website https://www. votervoice.net/AmericanLegion/home. It is so important for all of us to sign up and notify our elected officials of what is important to veterans. ur nation owes American veterans an enormous debt, one that can never truly be repaid. Honoring our commitment to those who served our nation in uniform involves continuing to support them when they return home and meeting the needs of veterans who are disabled.

Last Congress, I authored a bill with Senator Joe Manchin (D-WV) that will make a positive difference in the lives of disabled veterans who require adaptive modification of their vehicles long after they are discharged or retire from active duty. I am delighted that our legislation received overwhelming bipartisan support from our colleagues, and it was signed into law in January.

The provisions of the bipartisan Advancing Uniform Transportation Opportunities (AUTO) for Veterans Act, enacted into law as part of the Veterans Auto and Education Improvement Act of 2022, will make these veterans eligible to receive a grant to help purchase a new adaptive vehicle once every ten years, helping them to drive safely and

Under the previous law, the U.S. Department of Veterans Affairs was authorized to provide eligible veterans with a one-time grant of approximately \$21,400 to be used to purchase a new or used automobile and necessary adaptive equipment, such as specialized pedals or switches. The grant is often used

The AUTO for Veterans Act addressed this limitation, which failed to take into account that a disabled veteran may need more than one vehicle in his or her lifetime.

According to the Department of Transportation, the average age of a household vehicle is 11.8 years, and a vehicle that has been modified structurally tends to have a shorter useful life. The substantial costs of modified vehicles, coupled with inflation, present a significant financial hardship for many together with the VA Special Adaptive disabled veterans who need to replace

once their car, or van, or truck reaches the end of its lifespan.

A Maine veteran whom I know well, Neal Williams of Shirley, used a VA automobile grant in 1999 to purchase an adaptive vehicle, a Ford Econoline van. He also had to purchase several adaptive vehicles since 1999, with Although veterans could receive each one lasting more than 250,000 miles until they simply were no longer road-worthy. He told me that purchasing a new van will cost him well over \$50,000, which is more than he paid for

The big news is still about the PACT act. A good idea is to add information from the Pact Act to your call script. If you are calling a Vietnam-era veteran, start off the call with the added locations and conditions. It may help to get a good conversation started.

There are still questions on the PACT Act so I will again list some of the major changes due to the act passing and becoming law. For the Vietnam veterans, the act added these locations: Guam or American Samoa, Johnston Atoll, Cambodia, Thailand, and Laos. For the Gulf War and 911 veterans, the act added these locations: from 1990 Bahrain, Iraq, Kuwait, Oman, Oatar, Saudi Arabia, Somalia, and the United Arab Emirates. Then from 2001 Afghanistan, Djibouti, Egypt, Jordan, Lebanon, Syria, Uzbekistan, and Yemen.

The act also added 2 presumptive conditions for exposure to agent orange and over 20 for exposure to burn pits and toxic exposure. If you have any questions, please call the office.

PLEASE READ AND RESPOND

APPEALS OF CLAIMS. The appeals process is no longer the strict structure it was. If your decision was after the 19th of February, you fall under the AMA. There are now five lanes you can choose from. The first two are at the regional level. They are called supplemental review and higher-level review. Then there are three ways to appeal directly to the Board of Veterans Appeals. They are direct, evidence only, and hearing. The time limit is now one year from each decision.

Contacting the DSO for Assistance by Telephone - Please just leave your name, phone number, and who you are working with.

Financial Assistance. Keep in mind that requests for financial needs should be directed to your town/city for general assistance (GA), and either a local Legion post for a possible fundraiser or the American Legion Department Headquarters. In addition, we can make referrals to other service organizations, but we do not have the funds to pay rent, mortgage, credit card bills or oth-

er ongoing bills. If you have children, mention TFA to the Department Adjutant when you call to see if you are eligible to apply.

PSO Training Seminar. You do not have to be a Post Service Officer to attend training. You just have to care and want to make a difference.

PSO Contact Information. Post Service Officers, as a minimum, please send us your full name, Post, telephone number (your phone number will not be released) and email address. The purpose

is so that members of your post can contact you for local assistance and also so that I can contact you, by phone or email, if we hear from a member in your post that needs assistance.

INTENT TO FILE. Some veterans are not ready to file a claim or are looking Fri between 8 am and 8 pm, EST. for additional information. In that case, vou can execute an Intent to File with our office. That is NOT a claim for benefits. You have 1 year to file your claim; one year period! Failure to file in one year starts the clock on your claim from the day you file. **DO NOT FORGET** TO FOLLOW UP AND FILE YOUR CLAIM!

Quilts of Valor

Then you hear the word 'quilt,' to keep out the cold. what do you think of? Most of us envision a warm and thick bed covering or blanket with padding enclosed between layers of richly colored, decorative fabric that may have laid on a grandparents' bed or was received as a gift from some older relative, or perhaps joined together fabric or padding with lines of stitching to form a warm bed covering or garment.

The history of quilts began long before European settlers arrived in the New World. People all over the world had used padded fabrics for clothing, bedding, and even armor. With the arrival of the English and Dutch settlers ly. in North America however, quilting took on a new life and flourished.

The quilt, as we know it in America, was originally a strictly utilitarian article, born of the necessity of providing warm covers for beds. Quilts were also used as hangings for doors and windows that were not sealed well enough of Valor asks if the potential recipient

These thick, cozy coverings, in all their definitions, can also be used to cover service members and veterans touched by war with comfort and healing, as is the mission of an organization known as Quilts of Valor.

The National Quilts of Valor Foundation tells us their quilts are only presented to service members and living Veterans of the U.S. Armed Forces. QOVF acknowledges and appreciates the support of their families and strives to remember and honor those who have given their lives for our freedoms, but they do not award QOVs posthumous-

Quilts are to be awarded, not just passed out like magazines or videos. A Quilt of Valor says unequivocally, "Thank you for your service, sacrifice, and valor" in serving our nation in combat.

The nomination process for a Quilt

of Valor would bring comfort and healing, and that the recipient has not previously been awarded a Quilt of Valor.

'Quality over quantity': Army's top general says lowering requirements to boost recruiting could be dangerous



6 Quality over quantity': Army's top general says lowering requirements to boost recruiting could be dangerous

The Army's top general warned Wednesday that lowering entry requirements for recruits is dangerous as the U.S. military looks for ways to attract troops who want to serve and can pass the physical and academic tests.

Gen. James McConville, the Army's chief of staff, said the challenges to increase recruiting numbers are formidable. By the end of 2022, the Army was hoping to have 473,000 troops, but ended up with about 465,000 after lowering its goal twice.

It's not just the Army. The other service branches are also having difficulty finding recruits who can meet physical and academic requirements.

"Here's what we do know. We have a lot of young men and women who want to serve — and they can't pass the ac-

ademic requirements or they can't pass the physical requirements," said McConville, who became the Army's chief of staff in 2019.

To join the Army, a recruit must be between the ages of 17 and 35, medically and physically fit, and in good moral standing. Further, they must be a high school graduate, or the equivalent, and pass the Army's placement exam known as the Armed Services Vocational Aptitude Battery test. According to Pentagon data, 23% of Americans between the ages of 17 and 24 meet all eligibility requirements.

"We are facing unprecedented challenges recruiting new soldiers. Among a myriad of causes, America's youth are less qualified for service than ever before," said Army Brig. Gen. Patrick Michaelis, commander at Fort Jackson, S.C. "Since the all-volunteer force was established in 1973, this is the hardest

to meet recruiting goals."

Army officials have said the coronavirus pandemic has also made recruiting more difficult, as ASVAB test scores are provement. down almost 10% since the start of the

"They just can't pass it," McConville said. "It's harder for people today to pass it than it was before."

He also pointed to a university study done that found about half of high school ROTC students are also failing the ASV-AB test. But despite these recruiting hurdles, he said he remains opposed to relaxing entry requirements because the standards are there for a reason.

and unimaginable things can happen," McConville said, stressing the importance of troops' intellect and physical capabilities during conflict.

"What we are not willing to do is ... we don't want to lower standards," he said, noting Defense Secretary Lloyd Austin shares his opinion. "We think that quality is more important than quantity."

> "It got about a 95% success rate. Either they are improving their scores or they are losing body fat," McConville said. "When they go into initial military training, they have got a heads up on their peers."

> He said the prep course could save the Pentagon money by helping to weed out recruits before they get to the stage where the military starts investing in their futures.

"I think we are going to have to do this "This could be a very dangerous time if we don't want to lower standards," McConville said. "We want to give people an opportunity to do great things."

> "In fact, we want them to be all they can be," he added, harking back to the Army's "Be All You Can Be" slogan from the 1980s and 1990s — a slogan so fondly remembered that the service is bringing it back in 2023 as part of its evolving recruiting plans.

Another avenue that the Army wants "What we are willing to do is we're to follow, McConville said, is finding recruits in families that don't have a lot of military connections. He emphasized tionally come from military families.

"We really need to make it not a military family business — but an American family business," he said.




Windham Post 148 & SLAA Gifts Ice




November arrived with Post 28 prepar-



Preparing for the July 4 parade takes longer and is more involved, Hendricks said. He said member Mike Barnes led this year's effort starting around April getting the trailer and float ready. "You don't just up and do that sort of thing just two weeks prior, for a few hours," Hendricks said. 

The concept of 'ICE' is catching on quickly. It is a method of contact during emergency situations. As cell (mobile) phones are carried by the majority of the population, all you need to do is store the number of a contact person or persons who should be contacted during emergency under the name 'ICE' (In Case Of Emergency).

The idea was thought up by a paramedic who found that when he went to the scenes of accidents, there were always mobile phones with patients, but they didn't know which number to call. He therefore thought that it would be a good idea if there was a nationally recognized name for this purpose. In an emergency situation, Emergency Service personnel and hospital Staff would be able to quickly contact the right person by simply dialing the number you have stored as 'ICE.'

For more than one contact name simply enter ICE1, ICE2 and ICE3 etc. A great idea that will make a difference!




