

As the post/district election season is upon us, remember to get the new Officers Form into department headquarters as soon as possible after the Post forms that you must ensure are turned in are as follows:

depicts all post information currently on file at national and department HQ. Review and make any necessary changes or corrections and submit to department HQ. This form is not available online. This form had a deadline of being turned into Dept. by Apr. 15, so if you STILL haven't turned it in by now, you are EXTREMELY late.

Consolidated Post Report (CPR) -You have two reporting options with this report. Online using MyLegion.org or by mail using the paper form which can be found on the department website. This report is due at national Jul. 1, if mailed; it is due to department by May 29.

Notification of Post/Squadron Commanders and Adjutants Form – Due as soon as new officers are elected for the current year of no later than Jul. 1. The post adjutant is to complete the form and submit it to the department even if the post does not have a squadron.

Post Officers Form – This form must be filled out even if there are no changes from previous year. The form is due to department by Jul. 1.

The District Officers Form is to be filled out by the district adjutant and submitted even if there are no changes from the previous year. This form is or District Installation is complete. Pricia Thurston enlisted in the U.S. Navy at the age

"I remember my mother having to sign for me due to being underage. I turned 18 years old in boot camp," said Thurston. "I went into the Navy without a guaranteed A school [training program]. It's crazy to realize how brave I was to do this."

Her first duty station was in Scotland, where she met her future husband, Kirk. Following marriage, the cou- Legion in 2006 that I could stand taller as a womple moved to California, where she served in the Navy Reserve, until their move to Japan.

Thurston first learned of The American Legion Family when her husband joined The American Legion through the mail, before ever visiting a post. Soon after he joined, they attended a local event and discovered his post was being revitalized and seeking new officers. To their surprise, he was nominated for 2nd vice commander of the post. Shortly after he took office, he encouraged Thurston to check out the Legion and join.

"He said, 'You know you can join as well.' I answered, 'I don't think so, I am not a veteran. I didn't go to war or retire after 20 years.' He shared, 'Yes, you are. You served," said Thurston. "For some reason, I never thought of myself as a veteran. I was never told I was a veteran or was looked at as a veteran." This moment changed her thoughts on what a veteran is.

"It was then and the fact that I joined The American an veteran and also fight for others who also do not realize they are a veteran or considered a veteran by others," she said.

Thurston also joined the ALA at the same time she became a Legionnaire.

"With my husband becoming involved with the Legion, I decided to join both the Legion and the Auxiliary," said Thurston. "He served for 20 years. I was a Navy spouse longer than I served our great country.

Mar. 6. If you have not received them by now, I would hope you would have reached out to either myself or the department.

These forms are all uniquely important to the success of everything we do. Please ensure that your posts and districts are doing their part to get these turned in. If WE all can work together, we can all get them turned in. If you need help, please reach out and I am sure we can help.

Let's also not forget The American Legion Family Dirigo State Program. This year, it will be held at Colby College from Jun. 16-21. Completed forms (Dirigo State Application, Parental Consent. Medical Authorization and Performing Arts if participating) should be mailed to The American Legion, Department of Maine along with a check in the amount of \$400 per student.

I want to remind you all that our work is not done yet. Keep making those buddy checks, not just for membership alone, but to also let our brothers and sisters know we are here for each other and that we care. It's meaningful work.

It always reminds me of the saying, "10% of a group do 100% of the work." I think we can change that percentage. Through personal observations and we can increase participation and grow membership.

First, let's look at the reason(s) that one might have decided to become a member of The American Legion. This is simply answered if we ask ourselves and our membership, "What's your why?"

For me, I have always been involved volunteering somewhere since I was 8 vears old. I lived in Buffalo and volunteered at the Western NY Ronald McDonald House. Upon returning to Maine, I volunteered at the Good Shepherd Food Bank (and eventually became one of the Directors.)

The American Legion, to me, is something that not only supports other veterans, but it strengthens communities through good deeds. We are the world's largest veteran service organization, congressionally chartered, with a mission to protect, advance and improve the benefits of all veterans. Observing what posts were doing in Maine, I wanted to be a part of that team...a winning team. That meant that I would need to roll up my sleeves and get work done, whether I was serving food at fundraisers, supporting post programs or in the community supporting whatever efforts were needed to keep the organization current, visible and relevant.

With that said, we must continue to ask why we joined The American Legion. We should regularly ask our members the same question just to help them remember and remind them that their participation and involvement is needed and encouraged to be a successful, cohesive and productive group that population.

The real question, "Is our post doing the things that made me want to join it?" "Are we still doing the programs, events and functions that made us want to be a part of it?" This question always

lingers, "if the post was gone from the community...would anyone notice?" Are we doing the right things for veterans and the community to make a difference?

Member engagement is a crucial part of member participation and attendance. Why would anyone pay annual dues to do nothing each month? Why would anyone pay dues to be ignored or forgotten? While there are those who pay just to be a part of the "voice" that speaks to congress, we still have an obligation to stay connected with our valued members.

Think about this. There are as many as 31 days in a month. Our meetings are once a month for just a couple of hours. We have jobs, families, and life in general. Without reminders, our mission gets forgotten. By using emails, texts, first-hand experience, I truly believe newsletters, posters, social media, etc. we can connect and remind our members of our meetings, events, programs and needs. The American Legion has a program called "Buddy Checks." This is a great way to stay engaged with our members. Speaking with a Post in District 2 recently, a team of dedicated members performed over 200 buddy calls in a 30-day period. The result? An increase in attendance at meetings, a significant increase in membership retention (from a regular 80% of the set goal, to above 100%) and an increase in volunteers. It was infectious, the Squadron followed suit also having an increase in participation at meetings and at fundraisers.

> Continuing to remind our members we make a bigger impact together and they are valued, keeps them interested and they will want to continue to be a part of something that realizes they are more than a number, more than a name on a piece of paper (roster) and more than someone who provides \$\$\$ to our causes. Involvement becomes "buy in", meaning they truly feel they are a part of the pack.

> We should follow membership engagement with community engagement. What valuable resources are available in your community that could provide publicity and awareness of your organization and the services you have to offer? Visibility is a big part of that; be at the patriotic events at the school, participate in the parades, attend flag retirement functions, show up at The Legion baseball game, have a Legion team volunteer at the local food pantry.

Are The American Legion programs serves our community and its veteran our Post has chosen to be involved in, being run and performed effectively? Programs such as DIRIGO State, Oratorical Competition, American Legion Baseball, etc. are valuable tools to our members as well as our community.


en our principles of serving veterans and the military, championing veteran benefits and effecting positive change in our communities. However, amidst our noble mission, it's imperative to recognize the paramount importance of ethics within our organization.

Ethics serve as the moral compass guiding the actions, decisions and behaviors of individuals and organizations. Despite the undeniable importance of ethics, Legionnaires may face ethical dilemmas and challenges in their day-to-day operations. Limited resources, competing priorities, and external pressures can strain ethical decision-making processes. However, it is precisely during such moments that ethical principles must guide actions and choices, even if they entail difficult sacrifices or compromises.

Our organization requires trust and credibility from those we serve as well as our members. We are all stakeholders in our post, which means we must have the trust and confidence in our officers, in our department and at the national organizational level. It is not just our board that bears the responsibility of fiduciary duty. Members must acknowledge their own responsibilities when nominating and electing officers, keeping abreast of the financial solvency of their post, and keeping true to our

In a time when resources are scarce and money is tight, all members should take exceptional interest in the financial happenings of their post. Financial mismanagement poses a significant threat to the stability and credibility of a post, potentially undermining its ability to fulfill the mission and serve its beneficiaries effectively. Mis-allocation of funds, embezzlement or fraudulent activities can erode donor trust and tarnish the post's reputation. Moreover, financial mismanagement may result in regulatory violations, legal consequences and loss of funding opportunities. Scarce resources intended for programmatic activities may be diverted to cover financial losses or liabilities, compromising the post's impact and sustainability. Additionally, a lack of transparency and accountability in fi-

How to add and manage multiple addresses:

- Visit www.MyLegion.org and click "Login" (or click "Register" to create an account if this is your first time using MyLegion)
- Click on the red "My Account" button
- On the left-hand side in the navigation pane, click on "Addresses"
- Click "Add Address" to create your secondary address
- Enter your secondary address information
 - Keep "Address Type" set as Home
 - Click the box to "Make this my Main Address" and click "Save"
- You will now see a Main Address (Home) and Additional Address (Home)
- You can switch your address at any time by clicking "Edit" and selecting or unselecting the "Make this my Main Address" box.

Imagine the impact that getting into our schools might have by providing scholarship information and opportunities to our youth. With the proper information given to the school administrators and counselors, they can pass down the opportunity for "free" (scholarships) money to interested students. Think about how we could impact our programs. What could our community see about us by forming a competitive baseball team that just might compete for a regional and/or national championship?

We need these programs to infuse our posts and communities with energy and commitment.

This is a huge issue. I have heard it at almost every post I have ever visited. "Why do new members come once and then we never see them again?"

The most obvious answer that I observe is that, once they have signed up and paid their initial dues, they are ignored! Do you have a welcome kit for new members? Did you give them a tour and history of your post? Did you get them a copy of bylaws? Did you share with them the programs run at the post or upcoming events? Give them a reason to be part of that winning team. Do follow up calls to check on them. Did you introduce them to the service officer or explain any benefits available?

So many times, I have noticed that there isn't any form of recognition for them. There is not an initiation ceremony. They are not welcomed or noticed by members in attendance. And they are left to fend for themselves. There is no attempt to welcome, mentor, train or assign someone to help them acclimate to your group. They do not feel valued, important, needed, included or noticed from the start. They feel as if they are nothing more than a donor, a shadow, a non-entity.

When we do recognize their membership, we then immediately say, "Have we got a job for you!" In both cases, they will run like scared rabbits. You will, most likely, never hear from them again.

Why are we not providing them with a mentor? A person they can relate with who will help them acclimate and learn about your group, your organization and its programs, services and needs.

We should allow them time to discover how they fit into your post. Allow time to provide them with information and have someone guide them through some training (start with The American Legion Basic Training, it's free online).

As they become familiar with your group, take time to assess their strengths

and weaknesses. See how they might fit into a role of future leadership or how they could provide value and energy with new and fresh ideas that benefit or upgrade your programs and post.

Once they do find their place and you assess their qualities, ask them if they might be interested in whatever it is. Once you have asked, then they have the choice to accept or decline. If they decline, move on. Maybe they will be interested in something else. If they acyouth with flag education and etiquette cept, then give them the expectations and then let them move forward and assist them when they ask. Follow up with them regularly.

When and if they choose to take on leadership, or if they just have ideas or suggestions, don't discourage them by rejecting them. Take time to discovpride and respect for the veterans that er how they think it works, give them continue to serve AFTER their service the opportunity to work out the idea by fleshing out the plan and then have them present it in full form. When this happens, acknowledge all they have

> When we continue to resist change, new ideas, new energy and vitality that the younger, new members bring, we discourage future leaders from stepping up and taking the reins as we get older and become less able to be involved as much as we once were.

> We must remember that these young veterans are the future of our organization and without them and their commitment, involvement and encouragement from us The American Legion will continue to decrease in members and our voice to congress. They will eventually lose benefits that they de-



nancial practices can lead to decreased stakeholder confidence and reluctance among donors to contribute, exacerbating financial challenges and hindering the post's ability to achieve its goals.

Every post should have an active financial review committee (FRC) that oversees post's finances above and beyond the finance officer or hired accountant/bookkeeper. The FRC should meet at least quarterly to review and reconcile accounts. For posts with active, profitable lounges and gaming, the FRC should meet bi-monthly. The FRC will ensure accountability of volunteer/ hired staff, review invoices, question expenditures, confirm the right people have access to bank accounts at the right time to name a few items for review. The FRC should review employee payroll and ensure said payroll complies with state and federal tax authorities and reported annually during tax season. Under the table payments to employees can jeopardize both the post and employee.

Post members should be engaged during meetings when financial decisions are made. Understand precisely

what the post is paying for particularly if said payment is benefiting a Legion Family member. Know the details of the proposed motion, actively discuss and question, make an informed decision prior to voting.

Ethical behavior often goes hand in hand with legal compliance. We operate within a complex regulatory landscape, and adherence to ethical standards helps us navigate legal requirements effectively. By avoiding unethical practices such as fraud, embezzlement or conflicts of interest, we mitigate the risk of legal repercussions that could jeopardize our operations and tarnish our reputation.

Ethics are integral to the long-term sustainability of the post. By upholding standards, we ensure continued support from members, volunteers, and donors. Moreover, ethical behavior inspires loyalty and commitment among members and staff, reducing turnover and maintaining institutional knowledge and expertise over time. Sustainable growth and impact are achievable only when a post operates ethically and responsibly.

Message From Maine Senator Angus King

aine proudly boasts Lone of the largest concentrations of veterans in the country — our friends, family members, and neighbors are the true embodiment of "Dirigo" and what it means to lead others in a life of service. Our veterans and servicemembers have made many sacrifices over the course of their careers. It's our patriotic duty to return to them the same service they gave to us.

This month, coming off the recent ruling in the Alabama Supreme Court that could have outlawed in vitro fertilization (IVF), I worked with my colleagues to introduce the bipartisan <u>Veterans and Families</u> Health Services Act. Beyond their selfless dedication and service, America's servicemembers should never sacrifice when it comes to starting or expanding their family. This pro-family bill would permanently authorize fertility treatments and counseling from the Department of Defense (DoD) and Department of Veterans' Affairs (VA), and allow servicemembers to cryopreserve embryos and reproductive cells prior to deployment to a combat zone or hazardous duty zone. With recent war veterans experiencing infertility at higher rates than the general public due to service related injuries and disabilities, IVF and other fertility treatments provide important hope.

And while we need to ensure the brave men and women who answered the call to serve are able to make their own family planning decisions, we also need to ensure that we care for women veterans who

bipartisan group of my colleagues in writing to the <u>VA</u> urging the agency to make it easier for women veterans who experienced sexual trauma to access physical and mental health care. This care is so necessary, with statistics showing that about 1 in 3 women experience sexual trauma during their time in service. Yet, right now, only half of the VA's services are utilized to help these survivors. We are calling on the VA to build trust and open doors so more women veterans can get the critical care they need to start recover-

in writing to the VA to finally have Maine Veterans' Homes (MVH) fully reimbursed for domiciliary care, as Congress authorized in 2020. The delay in getting this rule changed is causing significant financial harm to veterans, their families and MVH's finances. As it stands, there are families in Maine unnecessarily paying over \$1,500 per month to ensure their veteran gets care, and MVH is expected to lose \$3.9 million by the end of the fiscal year if nothing is changed. That is unacceptable. I'm going to continue pressing the VA until we get this rule finalized and remove financial burdens that are causing undue stress both to our veterans and those that care for them.

With so many of our veterans choosing to live outside of the bigger cities and towns, my friend Senator Kevin Cramer (R-ND) and I also introduced bipartisan legislation that would assess the VA's ability to meet needs of elderly veterans in delivering rural long term care (LTC). Last year, the Centers for Medicare and Medicaid Services (CMS) proposed a minimum staffing rule for LTC facilities. However, while policy sometimes looks good on paper, it is not always good in practice. This one-size-fits-all solution has the potential to shut down rural care facilities that might not cessing their well-deserved benefits.

have experienced sexual trauma. That's why I led a be able to meet the same staffing thresholds as larger communities, depriving veterans of the care they earned and deserve.

Lastly, I spent time with my colleague Jerry Moran (R-KS) in introducing a bill that would streamline how veterans can have their disability claims processed. Specifically, it would make permanent a pilot program that was created by Congress in 2020 to permanently allow licensed medical professionals to provide medical disability examinations across state lines for the VA. Prior to the pilot program, the Vet-I also joined the Maine Congressional Delegation erans Health Administration was the sole gateway for veterans to get disability claims. By allowing veterans to use any VA-approved, licensed medical professional to perform their benefits exam — rather than force everyone into an overwhelmed local bottleneck - we can help alleviate the backlog and ensure our veterans receive the benefits they've earned in a timely manner. This bipartisan bill is yet another way we can express our gratitude to the brave men and women who've served.

My comfort level at this time was with other spouses and those who were eligible through their family's service."

"I feel that I bring experiences of being both a veteran and a spouse of a veteran. As a veteran, I bring education that women are veterans too," said Thurston.

She urges members to not make assumptions that someone is or is not a veteran based on their sex. Women veterans have unique experiences and it's important for them to share ideas and information with fellow members to provide support in their communities.



special court-martial) apply for VA benefits services. carefully review their records to determine if we can provide them the requested care and benefits. This process helps ensure that VA can provide services to deserving former service members including certain individuals who

faced discrimination, survived sexual assault or harassment, struggled with their mental or physical health, or faced other challenges while serving in the military.

VA's new regulation will expand access to care and benefits for certain former service members by:

• Eliminating the regulatory bar for "homosexual acts involving aggravating circumstances or other factors affecting the performance of duty" as a bar to benefits. While VA had already taken steps to ensure full and fair access to benefits for former service members discharged based on homosexual conduct, gender identity, or HIV status, this move further solidifies VA's commitment to reducing disparity for these groups in the adjudication process.

- members: For certain former members discharged for "willful and persistent misconduct" or an "offense involving moral turpitude," VA will now consider and determine if a compelling circumstances exception will permit VA to nonetheless provide care and services. Under this exception, VA will consider the former service member's length and character of service, mental and cognitive impairment, physical health, combat-related hardship, whether the person was the survivor of sexual abuse/assault or discrimination, and more. This new exception creates a new path for VA to provide benefits and services to deserving former service members.
- Opening the door for previously denied service members to reapply: Because of these changes, former service members previously found ineligible for VA services may now be eligible for benefits and are encouraged to reapply.

"We encourage former service members with other than honorable discharges to apply for VA care and benefits today," said VA Secretary Denis McDonough. "Although VA cannot change your discharge status, we want to provide you with any health care or benefits we can – and we will work with you every step of the way to do exactly that."

Creating a "compelling circumstances recent years, increasing the number who applied exception" for certain former service for VA care or benefits from approximately 1,700 in members: For certain former service 2012 to more than 10,000 in 2023.

The VA character of discharge determination does not change the Armed Forces' characterization of service and has no effect on the former Service member's military discharge status. VA's determination is for VA benefits and services eligibility purposes only.

Any discharge characterized as "honorable" or "general – under honorable conditions" satisfies the character of discharge requirement for basic eligibility for most VA benefits. Former service members who did not receive those discharges are not automatically disqualified from receiving VA care or benefits. However, barring a ruling of insanity, VA does not provide benefits to service members who are discharged with a "dishonorable discharge;" service members who were discharged for desertion, mutiny, going AWOL for 180 continuous days, or espionage; or service members discharged by sentence of a general court martial, discharged in lieu of trial, discharged as a "resignation by an officer for the good of the service," or discharged as a conscientious objector. VA does apply a compelling circumstances exception for AWOL when appropriate.

n behalf of Maine Veterans In Need (MVN), I want to thank The American Legion Topsham Post 202 and Damariscotta Post 42 for their Winter Classic Softball Games fundraisers for MVN on Sat., Feb. 17. Each year, the event grows with players coming from all over the state. Whoever thought playing softball in the snow would be so much fun and would draw such a crowd? And the players, while having fun, were really competitive! At last count, the two posts raised over \$24,000 for MVN. Most knew that this fundraiser was for homeless veterans but didn't really know what MVN as an organization is all about. I hope to change that by visiting as many American Legion Posts as possible over the next year. Briefly, MVN is an all-volunteer organization that does not take government money, operates 24/7 and can provide IMMEDIATE help for veterans in need when all government funded programs can't. Most programs require a process and that takes time. Some have rules, such as how long you served, where you served, character of discharge, have a DD 214, and so forth. MVN only requires that they be

Perhaps more importantly, while we meet the immediate need, we connect the veteran with the other resources that can provide more substantial relief going forward. Since we are 24/7, many of our calls come on Fridays or over the weekends when no one else is available. So clearly, without The American Legion and the Winter Classic, we would not be able to help those veterans in emergency situations immediately when they happen. And, of course, working with The American Legion's Veterans Emergency Financial Assistance Program (VEFAP) often allows the more substantial funding required to help in the long term.

Today, the #1 issue facing those who served is veteran suicide. According to the National Veteran Suicide Prevention Annual Report. 17 veterans still die by suicide each day, or more than 6,000 each year. The rate of suicide for veterans is more than 50% higher than that of non-veteran adults.

The American Legion is activating a national platform to end veteran suicide.

The Be The One campaign will: Destignatize asking for mental health support, creating opportunities for those with mental health issues to speak freely and get the support they need; Provide peer-to-peer support and resources in local communities; Deploy FDA-approved therapeutics for veterans to identify issues and find resources for support.

The American Legion Department is announcing training dates for the BE The American Legion Department of Maine THE ONE initiative, a campaign aimed at reducing the rate of veteran suicide. The American Legion is leading a nationwide effort — "Be The One"— to eliminate the stigma related to mental health treatment, and in turn, lower the number of veterans who die by suicide every day.

The number of veterans who die by suicide every day is estimated at between 17 and 22. The American Legion has elevated Be The One to be its top priority, empowering veterans, servicemembers, their family members and civilians to act appropriately when a veteran may be at risk. This training intends to bring more awareness to the problem while providing resources to those who may be able to help save the life of a veteran.

Rumford Post 24 Four Chaplains Day

February is set as the day to remember and honor the sacrifices of the four degrees by military and civilian groups States and overseas.

These four men were assigned to a chaplains. It is celebrated to varying ship called the SS Dorchester. During World War II, there were men Who are the four chaplains? enlisting from all over the country of different backgrounds. The Dorchester was a passenger ship. It had been Reverend George L. Fox, Jewish Rabbi requisitioned by The Army and it Alexander Goode, Catholic Priest was transporting 900 plus troops to Father Washington, and a Reformed Greenland as part of a convoy with a couple of other troop ships and some Coast Guard escorts.

In the early morning hours of Feb. 3, 1943, the U.S.A.T. Dorchester was crowded to capacity, carrying 902 servicemen, merchant seamen and civilian workers. Once a luxury coastal liner, the 5,649-ton vessel had been converted into an Army transport ship. The Dorchester, one of three ships in the SG-19 convoy, was moving steadily across the icy waters from Newfoundland toward an American Church in America Minister Reverend base in Greenland. SG-19 was escorted by Coast Guard Cutters Tampa,

The men on The Dorchester sailed together for 11 days in very close quarters, so they would see the clergymen together setting up for their respective services. They each gave up their life jackets to enlisted soldiers would comment on how well the representatives of various denominations got along and that when they preached, they seemed to be in most ways more united in faith than separated.

During the early morning hours of Feb. 3, 1943 at 12:55 a.m., The SS Dorchester was torpedoed by German submarine *U-223*. The damage was severe, boiler power was lost and there was inadequate steam to sound the full 6-whistle signal to abandon ship. Through the pandemonium, according to those present, four Army Chaplains brought hope in despair and light in darkness. Those chaplains were Lt. George L. Fox, Methodist; Lt. Alexander D. Goode, Jewish; Lt. John P. Washington, Roman Catholic; and Lt. Clark V. Poling, Dutch Reformed. Quickly and quietly, the four chaplains spread out among the soldiers. Though they were four chaplains of different faith denominations, they are remembered for their acts of bravery and heroism. These four men met each other where they received their Army Chaplain training at the Army Chaplain School at Harvard University.

When most of the men were topside, the chaplains opened a storage locker and began distributing life jackets. It was then that a crewmember witnessed an astonishing sight. When there were no more lifejackets in the storage room, the chaplains removed theirs and gave them to four frightened young men. > As the ship went down, survivors in nearby rafts could see the four chaplains-arms linked and braced against the slanting deck. Their voices could also be heard offering prayers. Of the 902 men aboard the U.S.A.T. Dorchester, 672 died, leaving 230 survivors.

> Reverend Fox, Rabbi Goode, Reverend Poling and Father Washington passed life's ultimate test. In doing so, they became an enduring example of extraordinary faith, courage and selflessness. The Distinguished Service Cross and Purple Heart were awarded posthumously on Dec. 19, 1944 to the next of kin by Lt. Gen. Brehon B. Somervell, Commanding General of the Army Service Forces, in a ceremony at the post chapel at Fort Myer, VA. A one-time-only posthumous Special Medal for Heroism was authorized by Congress and awarded by President Eisenhower on Jan. 18, 1961. The special medal was intended to have the same weight and importance as the Medal of Honor.

Pacific Theater. Receiving his training in Hawaii, he went ashore in the Adjutant General Corps on day one of the invasion of Saipan. Following the war, both brothers rose to become vice-presidents of the corporations at which they were employed, Al at Wheeling Pittsburg Steel Company, and Bert at Vern Donnay Homes.

After his recovery and honorable discharge, Harry was a salesman in the exclusive Liemandt's Men's Furnishing store in downtown Minneapolis, where he remained for many years until he was lured away by his second oldest brother to sell homes for Donnay, from which he retired. Donnay Homes is a big deal in Minnesota, having developed tracts containing 16,000 homes of various affordable models, from 1941 to date.

Harry and I shared something more than just a first name. Just after he was inducted in March 1943, home on a pass, he and I were baptized together on the same day in the Calvary Lutheran Church a few months after my birth. His mother had passed when he was

about six years old, and for some reason, his baptism had not previously taken place.

After induction, and Basic Training, he was posted to the Armor School to learn the skills of a tank machine gunner. Upon graduation in June, 1944, he apparently was given leave at which time he married Elizabeth "Betty" rada Allen. He must have been fairly proficient as a gunner, as when the opportunity arose, he was transferred into the United States Army Air Corps, pdf

to receive additional training as a heavy bomber machine gunner at Pyote Army Air Force Base in Texas. There he and Betty shared with two other enlisted married personnel, on-base housing, with one room per couple. He was trained in both B17 waist and turret, and B29 blister remote gunnery He preferred the latter, as B29's had pressurized crew compartments, while B17 waist gunners were subjected to over 200 mph winds in open air stations.

When Harry completed his training, Betty returned to Minneapolis, pregnant with their daughter, and Harry was transferred to the Pacific Theater in March, 1945. Arriving on Tinian Island, in the Marianas Chain on March 14, 1945, he was assigned as a replacement on the 11-man crew of the B29 "Tokyo Trolley" bomber. His assigned Wing, the 313th Circle "R", though he knew it not at the time, was the Wing that won the war against the Japanese.

It is rather amazing how much information is available concerning the individual bombers and crews that comprised the 20th United States Heavy Bomber Air Force that flew from the Marianas group of Guam, Saipan, and Tinian. For instance, each heavy bomber squadron, their Group, and Wing has its own history online, which includes a link by serial number to the contract of each bomber manufactured during the war. For instance, the "Tokyo Trolley" was built in the 2nd Contract (B29-30), to the Bell Aircraft Company, of Marietta, Georgia. Its serial number of 42-63553, indicated that it was the 2nd aircraft manufactured under that contract. The "Trolley" was subsequently assigned to 39th Very Heavy Bombardment "Pirates Cove" Squadron, of the 6th Bombardment Group, in the 313th Wing, stationed on North Field, Tinian.

Oxford's John Crumpton, Jr. Accepts the Boston Post Cane

After years of denying his eligibility, 99-year-old John Crumpton, Jr. has finally accepted the Boston Post Cane, along with the fact that he is indeed Oxford's oldest citizen.

Crumpton was awarded the cane Feb. 15 during Oxford's Board of Selectmen's meeting, with more than 20 well wishers in attendance.

Considered a town father and honored in 2019 with the dedication of Oxford's annual town report, Crumpton has lived in Oxford since the early 1980s. His Gorham-born wife Eva, who he married in 1950, informed him she was going to move home to Maine.

As he explained to the Sun Journal a few years ago, after his long career in the Navy, eight ships, three wars and 20 addresses shared between the couple, she resolved: "I'm going home now. Are you coming with me?"

"The answer, of course, was 'yes ma'am," he quipped.

Crumpton was born Oct. 24, 1924 in Craig Springs, Mississippi, a village so small it could not be found on a map. During his youth the town was comprised of about a half dozen houses, a school, Lutheran church and cemetery, and a crossroads.

His world expanded the same way as countless others of his generation – Japan's attack on Pearl Harbor on Dec. 7, 1941 and the United States' entry to World War II. Then 17, Crumpton and

his best friend Ray Bock determined to enlist in the U.S. Navv.

His father opposed Crumpton's plan, refusing to sign his enlistment papers. But when the son promised to defy his wishes and find someone on a street corner who would sign them instead, his father relented and gave his approval.

In 1943, while he served on the USS Memphis along the West African coast, the ship served as a stop-over for President Franklin Delano Roosevelt, who was on route to the Casablanca Conference with British Prime Minister Winston Churchill. Crumpton was in the group of sailors escorting Roosevelt aboard the ship and then was chosen to stand guard while the president fished with another sailor on the Gambia River.

He later met President Harry Truman who was inspecting troops during a brigade parade, and met with President-elect Richard Nixon at the White House in 1969 as he led a briefing on the Navy's shipbuilding program and budget.

Crumpton attended the U.S. Naval Academy starting in 1948, graduating four years later. From there he continued his 33-year career in the Navy, serving in both the Korean and Vietnam wars. He retired in 1975 with the rank of Captain and Commanding Officer of the USS Drake.

It was then Crumpton stopped giving orders to sailors and followed Eva's instead. The two eventually made their way to Oxford, moving to the Robinson Family Homestead where he still resides today. After 61 years of
