Wiley Elected **National Commander**

elected National ewly Commander Dan K. Wiley pledges to continue highlighting Legion's veteran suicide prevention mission, calls for teamwork among American Legion Family.


Upon being elected 2025-2026 American Legion National Commander on Aug. 28, Kansas Legionnaire Dan K. Wiley took the stage at the organization's 106th National Convention and thanked all of those who helped him get to this day.

And then he told a story.

It was the story of a young attorney in Wiley's hometown who, due to various circumstances, was going through a difficult time – one he thought was just physical.

When the attorney went to his doctor for some cold medicine, the doctor noticed a difference in his patient and began asking questions: "Do you value your work? Do others value your work? Do you think you are doing good work?"

Puzzled, the attorney said he just wanted his cold prescription, but the

attorney admitted he could not think clearly, explaining, "It's like I'm driving a car, and it is foggy, and I cannot get the defroster to work. I can stay on task and get things done, but I can't see ahead." He then agreed to take the prescription for 30 days, which improved his condition considerably. He was then advised to continue to take the prescription for one year.

team have a diverse background which include being trained in critical incident stress management and peer support, and we visit fire stations, police stations, hospitals, and veterans facilities to offer comfort and companionship to those who serve our communities.

The Angel: Ember was 9 weeks old when she moved in with Tim Nickels,

the goal was to have Ember become a therapy dog. It was discovered that Ember was attached to Tim but no one knew that would save him later on. Anytime



Tim was having a hard day or a bad shift Ember would sit with Tim. Tim was diagnosed with PTSD in 2020, Ember wouldn't leave his side. Ember knew something was up. Tim became suicidal and made attempts to end his life. Ember stopped him at least three times. When the days were dark, Ember wouldn't let him leave without her.

The Project: National American Legion asks Departments to partner with local organizations to support BE THE ONE. Commander McKenzie has chosen to partner with Ember's Paws of Hope (EPOH), an organization committed to provide, comfort, support, emotional healing to veterans first responders through the unconditional love and companionship of therapy dog. EPOH is dedicated to enhancing the wellbeing of those who serve our communities and country, offering a source of solace in times of stress, trauma and hardship.

The PLAN: We are asking all American Legion Posts and/or members to financially contribute to Ember's Paws of Hope. This new 501-c-3 needs funding to provide more trained therapy dogs and make more appearances to provide physical, emotional and social well-being to others in need.

We were introduced to the national officers, National Chaplain Rev. Michael J. Politt, NH, National Historian David Lockhart, NY, and Sergeant-at-Arms Gaylord K. Sanneman, KS. Also introduced were the five national vice commanders (NVC). Our NVC is Ronald L. LaRose from Vermont.

A resolution presented was one that the Department Advisory Committee brought forward and that was to reinstate the charter for the Department of Colorado with stipulations. Other resolutions came from the Finance Commission, the National Security Commission, Americanism Commission, Internal Affairs Commission, the Veterans Affairs & Rehabilitation Commission (VA&R), and the Veterans Employment & Education Commission (VE&E). There were reports received from various other commissions present.

Of the 30 total resolutions presented, two had to be referred to the respective commission for further study. On Thursday, those two resolutions were reintroduced with the necessary change made and were passed unanimously "as amended." The VA&R Commission presented 19 of the 30 resolutions to be brought up. All the resolutions will be available for viewing shortly on https://archive.legion.org.

A resolution from the VA&R Commission was that the dependents of the sailors known as the Port Chicago Fifty, of the 1940s, who have been exonerated of any wrongdoing, be granted any available benefits that they might be currently entitled.

Another resolution that was passed was that the Department of Veterans Affairs name all women veterans' rooms/clinics after women veterans. This was done in Salem, Virginia and in California.

Finally, from the VA&R Commission was a resolution urging Congress to increase from seven permanent judgeships on the U.S. Court of Appeals for Veterans Claims to nine permanent positions. Again, the VA&R Commission submitted a resolution to encourage the U.S. Census Bureau to modify its Title 13, United States code requirements to include veteran, National Guard, and reservists' data on any further census.

Until the next time, may you all enjoy good health and prosperity and have a good winter. I am available for any assistance I can do, and I remain "PROUD TO SERVE."

Retention: While recruiting new members is important, we must not forget our current members. Continue doing Buddy Checks, either by phone or in person. Please don't make Buddy Checks about membership. Take the time to check in on each other and find out what's going on in their lives. Make your membership calls separate. Let them know what events are coming up and offer to pick them up so they may attend. Ask them what they are looking for at your post. Some members don't attend because there may be a bar, or the meetings are late and run too long. Remember what works at one post may not work at another post.

Training: Take the time to train the new officers in your post, don't just hand over the reins and wish them luck. Mentor and help them with the position you hold, some of these members may be brand new and are unfamiliar with the way your post should run. They get confidence in me as your Department discouraged and frustrated and walk away from a position.

This year, as part of the Membership Plan, I have asked each district and each post to make up a two-or-three-

man membership team to assist the membership chair. Each district will reach out to the posts in his/her district and assist with membership issues. If your district has not yet reached out to you, please contact the district commander. I will be in contact with all the district membership team to get updates on how each post in their district is doing. I am in hopes that many posts will reach 100% before Dec. 31.

This year, we will continue to have a District Membership Contest. The district with the highest membership percentage, will be awarded a check for \$500 and the bragging rights for the year, and the second will receive a check for \$250. Also, for the district with the highest renewal percentage, \$500 and bragging rights will be awarded to the first place and \$250 to the second place. The contest will go on until 30 days prior to the 2026 Nation Convention. Have fun and good luck.



7our Rule Book, Your Rights: Y Why Every Legionnaire Must Know the Constitution and By-Laws.

The American Legion more than a social club; it is a powerful, nationwide organization dedicated serving to veterans their and communities. Like any great institution, strength

rooted in effectiveness and are foundational document—our Constitution and By-Laws.

To every Legionnaire, from the newest recruit to the seasoned Past Commander, these documents are not just rules for the officers; they are your blueprint for participation, your guarantee of rights, and the essential guide for fulfilling our sacred Preamble.

Here is why knowing your post, department, and national Constitution and By-Laws is a vital duty for every

1. They Define Our Mission and **Purpose**

The Preamble to The American Legion Constitution is our guiding star, laying out the core principles for which we associate ourselves together. From "uphold and defend the Constitution of the United States" to "consecrate and sanctify our comradeship by our devotion to mutual helpfulness," these are the why of our existence.

The Constitution formalizes this vision, ensuring that all actions taken by The American Legion—at every level—are directed toward our chartered purposes and remain non-political and non-partisan, as mandated by our founding principles.

Governance

Your Constitution and By-Laws are the fundamental rules by which your post operates. They ensure your post is a healthy, functioning organization.

- Order and Structure: They establish the framework for how your post is managed, including the hierarchy of responsibility and the relationship between the membership and the Executive Committee.
- Post Elections: They specify who is eligible to hold office, how officers are nominated and elected, and the length of their terms—ensuring a fair, democratic, and orderly transfer of leadership.
- Financial Integrity: They mandate the management of post funds, including the roles and duties of the Finance Officer and the requirement for an annual budget and audit. A member who knows the By-Laws understands how post money is handled and can ensure accountability.

3. They Protect Your Rights and

As a member in good standing, the By-Laws are your legal assurance of participation and protection within the organization.

- Your Right to Vote: The By-Laws dictate meeting frequency, quorum requirements, and the process for submitting resolutions—all of which determine how your voice is heard and how your vote impacts post decisions.
- Membership Status: They clearly define what constitutes good standing and what leads to delinquency or suspension. Knowing these rules is crucial to maintaining your privileges.
- Due Process: Should a disciplinary issue arise, the By-Laws outline the procedures for a fair trial and subsequent appeals, ensuring that no member is unfairly treated or removed without proper cause and process.
- 4. They Provide the "How-To" for **Operations**

While the Constitution covers the

2. They Are the Foundation of Good fundamental principles, the By-Laws are the practical, day-to-day operating rules. They are the "go-to source" for most of your post's specific procedures. Key provisions often include:

What the By-Laws Detail	Why It Matters to You	
Dues and Delinquency	Knowing payment deadlines and reinstatement procedures.	
Duties of Officers	Understanding the roles of the commander, adjutant, and others, so you know who to go to for specific needs.	
Delegates to Convention	Defining how your post selects representatives to department and national conventions, where major policy is set.	
Rules of Order	Establishing the parliamentary procedure (often Robert's Rules of Order) used to run meetings efficiently and fairly.	
Amending Documents	The procedure and vote threshold (often two-thirds) required to change the post's rules—a safeguard against hasty changes.	

5. They Ensure Compliance with the Larger Organization

Your post's documents are part of a larger legal framework. The hierarchy of rules is clear:

- 1. Federal/state laws
- 2. National Constitution & By-Laws
- 3. Department Constitution & By-Laws

4. Post Constitution & By-Laws

Your Post's rules cannot conflict with those of your department or national headquarters. Keeping yourself familiar with them ensures your post remains compliant and avoids legal or administrative trouble, allowing us to focus on our core mission.

Your Call to Action

The strength of The American Legion comes from an informed and engaged membership. You would not deploy without studying the mission, and you should not participate in your post without studying your Constitution and By-Laws.

- Ask for a Copy: Request a current copy of your post's Constitution and By-Laws from your post adjutant or judge advocate. They should be readily available to every member.
- Attend Training: Look for training opportunities on post operations and C&B. The American Legion offers resources like the Officer's Guide and various Training Tuesday sessions which often cover these topics in detail.
- Read Them, Learn Them, Live By Them: Don't just file them away. Familiarize yourself with them. When questions about procedure, membership, or leadership arise, your first and best resource is always the document you've agreed to uphold.
- By knowing your documents, you empower yourself, strengthen your post, and ensure that The American Legion continues to be the most effective force for veterans in America. Read them, learn them, and live by them. Our organization depends on it.

The American Legion, Department of Maine was established following the

St. Louis Caucus in May 1919, where the national organization was formed. Key figures from Maine, including the state's governor, played a role in the initial organization and the selection of the first department officers. The Department of Maine quickly began organizing local posts, with the first meeting held at the state house on July 23, 1919, with 25 posts already formed by that date.

Here's a more detailed look at our history: The American Legion was formed in Paris and St. Louis in the spring of 1919 by veterans returning from World War I.

Chairman Albert Greenlaw and Secretary James Boyle spearheaded the organization of local posts in Maine after returning from the St. Louis Caucus.

The American Legion's core mission in Maine, as elsewhere, includes supporting veterans, military personnel, and their families, as well as fostering patriotism and community involvement.

The first state convention was held in Bangor, Maine on Sept. 24, 1919. By the time the convention rolled around, Maine had 54 posts. At the first annual state, Albert Greenlaw was elected and subsequently served as the first commander for The American Legion, Department of Maine from 1919-1921.

About my post's namesake: Napoleon Ouellette, whom the Rumford American Legion Post 24 is named after, was born in Rumford, Maine in 1894. On Oct. 6, 1912, at the age of 18, he enlisted in the National Guard.

Ouellette reported for federal service on April 13, 1917. He made the ranks of private on Oct. 6, 1913, corporal on Sept. 9, 1916, and sergeant on April 27, 1917. He was originally assigned to Organization Company B 2nd Infantry of Maine National Guard, which was organized as Company B 103rd Infantry Defensive Sector Overseas: Sept 27, 1917 to death. what we do. It's who we are."

Wiley's theme of "Better Together" focuses on the American Legion Family. "I am a big believer in the American Legion Family," he said. "Those posts inclusive and not exclusive. They're the ones that operate in unity with the units, squadrons, and chapters. Those care about the mission and helping each other. Taking care of one another.

"But better together has an even deeper meaning. We use phrases like 'I got your 6' and 'I got your back'. Those are not just nice sayings. It's what we were trained to do when we served. It's human nature. It's who we are."

To illustrate his point, Wiley told how in December 2023 he received a phone call from American Legion Past National Commander Jake Comer, who had received an email from a disgruntled former court litigant.

"My first reaction was that I'm not too worried about someone attacking me. I'm used to it as a judge," Wiley said. "But when you start bothering my friends it upsets me. And I was mad."

Wiley said he called Comer back, and that the past national commander could tell quickly Wiley was upset. "About 10 seconds into the conversation he said, 'Dan, we had that forwarded to you for your situational awareness. We're not concerned about you. We know who you are," Wiley said. "And then the four words that mattered the most. He said, 'We got your back.' That's all I needed to hear. Powerful words in that moment."

Wiley plans to pay that forward to the men and women he will lead over the next 12 months. "This next year as your national commander, I got your has had your back since 1919. If you run across a vehicle with a veteran's license plate parked near you, stop, and talk to the person. He or she may be a veteran who has no idea what The American Legion does or what VA benefits there are available for them. There are many veterans and surviving spouses in the state who are not getting any kind of benefits. The only way this will change is if we take an active role in reaching out.

We are almost to the halfway point of the year; award nominations are due by May. The department website has all the forms you need. If the PSO at your post is doing a great job, please submit them for the PSO of the Year Award. The application is not hard to find and a little work on your part with be worth it in the end. APPEALS OF CLAIMS.

The appeals process is no longer the strict structure it was. If your decision was after the 19th of February, you fall under the AMA. There are now five lanes you can choose from. The first two are at the regional level. They are called supplemental review and higher-level review. Then there are three ways to appeal directly to the Board of Veterans Appeals. They are direct, evidence only, and hearing. The time limit is now one year from each decision.

Financial Assistance. Keep in mind that requests for financial needs should be directed to your town/city for general assistance (GA), and either a local Legion post for a possible fundraiser or the American Legion Department Headquarters. In addition, we can make

INTENT TO FILE. Some veterans are not ready to file a claim or are looking for additional information. In that case, you can execute an Intent to File with our office. That is NOT a claim for benefits. You have 1 year to file your claim; one year period! Failure to file in one year starts the clock on your claim from the day



you file. DO NOT FORGET TO FOLLOW UP AND FILE YOUR CLAIM!

This is one of the definitive areas in the National Security Pillar that is recognized at all levels, including the annual American Legion National Convention. The American Legion has maintained a collaboration with American Red Cross since 1942, when Legion blood drives supplemented the reserves stateside during the war effort. The American Legion continues to be the largest contributor of blood donor

support in the country,

During a recent discussion with one of the Red Cross Blood Drive Regional Directors, Geoff Allen, a few concerns were raised. There is, and continues to be, a need for more drives in the more populated areas. The Red Cross in Maine has room for expansion. These needs can translate into opportunities for local Legion posts.

There are some qualifying considerations that are addressed briefly:

First is location, preferably in a populated area that donors can be drawn from. The Red Cross would like to see at least 30 donors listed for a drive.

Second is a space that is at least 1,400 sq. ft., with adequate parking, a climatecontrolled space (68 to 70 degrees), handicap accessible, clean, well-lit, and adequate electrical outlets to support the Red Cross equipment.

Third is set-up of the space—this and staffing support are two of the most important considerations. The drive is more than just providing a physical space. Red Cross does appreciate having a free, clear location for their drives. The American Red Cross would like to see the space properly configured with appropriate tables and chairs for histology stations, an administrative table, a centrally-located supply table, a registration table at the entrance, and one or more tables to support the canteen.

The fourth consideration, in addition to the physical configuration, the Red Cross requests that the Legion Family provide staffing for the registration table as well as staffing to support the canteen (snack and drink table.) This could be as few as one to two individuals at each station. Most posts with a Legion Family should be able to support these staffing requests, which provide much needed support to the Red Cross staff.

As an example, Field-Allen Post 148 family in Windham provides two individuals at registration and two at the canteen, each covering a 3-hour period,

followed by a second shift until closing. So, a total of 8 Legion Family members. However, a post can get by with fewer staff.

Some posts have limited physical resources (space, etc.), but may still desire to support a blood drive. The post might consider collaborating with another organization or facility with appropriate accommodations, such as a local church, town facility, business, etc. With this collaboration, the post can then add the resulting drive numbers to its Consolidated Post Report (CPR), support its community, and receive credit for the drive

The fifth consideration is scheduling. How frequently should a Legion Family post host a blood drive? Good question; frequency of drives should be based on local population density, availability of Red Cross Blood Drive staffing, and coordination with the area Red Cross staff.

I would suggest that if a post has the space, and can support the blood drives, then a quarterly drive might work for your post. If you are committed to making the Red Cross Blood Drives a pillar in your Legion programs, then you might discuss with a Red Cross regional director how to become a Red Cross Blood Drive "HUB" in your area. The Field-Allen Post 148 in Windham has been designated as a HUB and is given scheduling priority for its monthly Red Cross Blood Drives.

Government Shutdown Resources, **Protecting Veterans' Access to Postsecondary Education**

s I write this, federal government is still down. While I hope that this is no longer the case by the time you read this, I recognize that veterans, niors, working families, and small. busi-

If you or someone you care about has been struggling, please reach out to my casework team — they're working as hard as ever to make sure Mainers can still get the help they need. I was the only House Democrat who voted to keep the government open before it shut down, and I've spoken at length about why at jaredgolden. substack.com. In short: the longer both sides try to "win" a government shutdown, the more Americans suffer the consequences from critical programs losing funding and agencies being stripped or shuttered.

While the shutdown has dominated the recent headlines in Washington, I've still been hard at work on other issues affecting veterans over the last few weeks.

Namely, at the end of September, I wrote a letter with the rest of Maine's Congressional Delegation to Education Secretary Linda McMahon pushing back against her decision to terminate funding for the TRIO Upward Bound program at the University of Southern Maine (as well as another educational

program at the University of Maine at Farmington). More than 125 veterans are able to receive counseling, tutoring, work-study opportunities, and more through USM's Veterans Upward Bound, and the program is popular enough that it even has a lengthy waitlist.

I'm proud to report that just days after our outreach, the Department of Education restored funding for USM's program. These were cuts that never should have been made in the first place, but I'm glad that

Maine veterans will continue to get access to the educational assistance they earned through their service to our country.

My office continues to help Maine challenges veterans overcome federal agencies, whether that's delivering delayed benefits, accessing personal military records and documents, or anything else in between. I'm proud of the team I've hired to take on these issues, and I hope you'll reach out if you have your own problem I can help you with, whether it is service-related or not. Honoring National Veterans and Military Families Month

November is National Veterans and Military Families Month. A time to honor those who give so much to defend our freedom. And while the 11th day of the 11th month was set aside originally to mark the end of the First World

War, Veterans Day now pays tribute to all who have served throughout our country's history.

Today, more than 18 million men and women bear the proud title of "veteran," including more than 106,000 here in Maine. Service is deeply woven into our state's heritage, and we are proud that so many heroes call Maine home.

It is the American character to answer the call of duty. It is also the American answer that call.

A truly remarkable demonstration of this spirit is Honor Flight, a national movement founded in 2004. Since that first flight, more than 300,000 veterans and their companions, including more than 1,300 Mainers, have had the opportunity to travel to Washington free of charge to visit the many memorials that honor American patriots throughout our history and across all branches of service. This year, as we mark the 250th anniversary of the United States Army, the Navy, and the United States Marine Corps, the 80th anniversary of the end of WWII, and the 50th anniversary of the end of the War in Vietnam, the importance of Honor Flight takes on even greater meaning.

I had the privilege last month of welcoming home 79 veterans who returned to Bangor from Washington after the fourth and final Honor Flight Maine trip of 2025. It was profoundly moving to meet with the heroes whose courage and sacrifice have kept our nation free. A large, cheering crowd greeted the veterans. Many of these veterans served in Korea, Vietnam, and in Cold War deployments, and the enthusiastic, affectionate, and respectful welcome they received was long overdue.

I applaud the volunteers with Honor Flight Maine for giving these veterans the experience of a lifetime and for providing the community with a chance

to express our gratitude to those who served ensuring, they know how much their sacrifice means to Maine and to our nation.

In addition to gratitude, our nation owes veterans the benefits they earned through their service. That includes programs that help service members pursue higher education opportunities when they return to civilian life.

One such program is the Veterans Upward Bound Program at the University of Southern Maine, which currently serves 125 veter-

ans and has a waitlist of many more. Despite Upward Bound's success in opening the doors of higher education to low-income and first-generation students, the U.S. Department of Education announced in September that it would terminate funding for two programs in Maine, including the one for veterans at USM.

I immediately joined with my Maine delegation colleagues in urging Educharacter to be grateful to those who cation Secretary Linda McMahon to reverse that misguided decision. Following my conversations with Secretary McMahon, the Department of Education agreed to release valuable funding for the University of Southern Maine's Veterans Upward Bound Program. Maine has one of the highest percentages of veterans in the nation, which is why initiatives like this are so important. I am thankful this program will continue so the veterans who have sacrificed so much for our nation have the opportunity to pursue higher education here in Maine.

> As Chair of the Appropriations Committee, I am pleased to report that the full Senate passed the Fiscal Year 2026 Military Construction and Veterans Affairs funding bill. In addition to the \$9 million I secured for vital projects for the Portsmouth Naval Shipyard and the Maine National Guard, the legislation strengthens the GI Bill for Apprenticeships, allowing veterans to use their education benefits for on-the-job training with financial support while they learn a trade or skill.

privilege to serve on the Senate Veterans' Affairs Committee. I am proud to work every day down in Washington making sure that our Maine veterans have the respect and benefits they have earned.

However, I would be hard pressed to not acknowledge the toll that the government shutdown has had - not just on the state of Maine - but on our veteran community. Throughout this process, I have understood the widespread impacts of what a shutdown does to responsivity to our veterans and all Maine people – so I have decided that it was in the best interests of all Maine people to continue voting to keep the government open. It is the least I could do for the veterans and people across Maine who serve us each and every day and deserve their benefits and services that they rely on.

If the Congress's most important job is to keep the government open, it is the Department of Veterans' Affairs number one job to be responsive to our veterans. But unfortunately, that is not the case. That is why my colleagues on the committee and I wrote a letter to the VA Secretary criticizing him for unnecessarily ending critical services for veterans during the shutdown and politicizing the lapse in appropriations to end communications with Congress. The Senate Veterans' Affairs Committee has always been one of the most bipartisan committees on Capitol Hill

and I am frustrated and angry that this administration is taking sides as veterans represent all sides of the political spectrum.

For example, earlier this fall, the Committee heard testimony from the nominee to serve as the VA Undersecretary for Benefits. During this testimony, the nominee explicitly avoided answering direct questions on the contract cancellations that have affected the services of veterans in Maine and across the country. We owe it to our veterans to always provide that care and when that care is not available -





Humanitarian Award. Accomplishments of the individual must be over and above his or her usual vocation; in most cases his/her deeds would not be in his/her chosen field of endeavor; but consideration would be given to someone whose activities in his/ her field of work was far in excess of what one would expect in that field. Applicants may be male or female, veteran or nonveteran, Legionnaire or non-Legionnaire. If there is a very close competition, a veteran should be chosen over a non-veteran, and a Legionnaire over a non-Legionnaire, all other things being equal. A majority vote of the Humanitarian Award Committee will be final.

Deadline for submission nominations will be May 1 of each year. Please ensure that the entire application is complete and at least two letters of support from parties having actual knowledge of the candidate's activities must also be submitted with the form.

Legion Honors General Henry Knox at 275th Commemoration

As Commander, Christopher S. Tourtellot heeded the summons. Orcutt informed the assemblage that he himself had commanded the Regiment from 1990 to 1993. When Commander Tourtellot arrived at the podium, Orcutt stated that the 275th Anniversary of General Knox's birth was a propitious time to present to the Col. Henry Knox Artillery Regt. of the MASSAR a Command Spontoon, which he handed to Commander Tourtellot.

Both American Legion District 5 Adjutant Orcutt and MASSAR Commander Tourtellot are also members of the Major General Henry Knox Mason-Lodge are U.S. veterans, and many are Legionnaires.

General Knox's life and accomplishments demonstrate why every patriotic American should render him honors. At age 12, Henry's father, a ship builder, died while employed in the West Indies. Henry, being the eldest of ten children, was left with the responsibility of providing for his mother and siblings. Other children of the family may have also helped, as it was the custom acts. A year later, Henry founded his in Europe and the American Colonies at the time that children at age seven could contribute to a family's welfare by performing light labor and be apprenticed for a skill at age 14. Henry had to drop out of the Boston Latin School, and was apprenticed to Nicholas Bowes, the proprietor of the Boston Wharton and Bowes Book Shop, where he was trained in book bindery, repair, and customer relations. The shop also doubled as a lending library, which allowed Henry to continue his education at home. In time, he narrowed his quest for knowledge to those of military matters, especially those of artillery and field fortifications. As the French were porter of Boston's Sons of Liberty, she the most proficient at that time in such subjects, he taught himself to become fluent in French.

In 1768, the British Government dispatched regiments to occupy Boston because of protests to the Stamp and Townsend Acts, resulting in a boycott of British goods, and precluding Henry from opening his own bookstore. Henry became a member of a militia company called "The Train," composed of ardent young men who were drilled with professional zeal by their Captain Adino Paddock. Henry, with the best elements of the company, founded The Boston Grenadier Guards, a unit that was a lot more than their resplendent uniforms. His military talents and knowledge being recognized, Henry was promoted to first lieutenant and thus became second in command.

On the night of March 5, 1770, coming upon a local disturbance of youths accosting a British Army soldier guarding the Customs House, with other soldiers having been called out, Henry tried to calm the situation by warning Captain Thomas Preston that if his men fired, it would result in the captain's losing his life. Preston assured him that he had no intention to order his seven-man Corporal's Guard to fire. Knox later testified to both the Boston Committee of Inquiry and at the soldiers' trial, that standing at the back edge of the square on King's Street, he observed the soldiers' ragged discharge of their muskets, which resulted in the death of five citizens, some of whom were ic Military Lodge of the Grand Lodge just observers. Before the Boston Masof Massachusetts AF & AM, with sacre, it was generally believed by 9 whom they annually attend the Knox out of 10 Americans that loyalty to the Commemorations. All members of the British Crown was assured. After the Massacre, a like number of Colonials believed that separation was inevitable. Also, consider this as a profile in courage: Knox was nineteen years and eight months old when he confronted armed soldiers loading their muskets, and yet he did everything possible to diffuse a very dangerous situation. He bears no fault for his failure.

Also in 1770, the Boston boycott ended with the repeal of the noxious bookstore, after establishing a relationship with a London book wholesaler. Knox's book store on Cornhill Street was named The London Book Store. It was an instant success and became a gathering place, described by one patron, cited by Wikipedia, as a "great resort for the British officers and Tory ladies, who were the ton at that period." Among his devoted patrons was the eighteen-year-old daughter of Thomas Flucker, a wealthy Tory and Royal Secretary of the Province of Massachusetts. Lucy married Henry against her family's wishes on June 16, 1774; because Henry was known to be a supwas disowned by her family. Theirs was a lifelong love affair that resulted in the birth of 13 children, of whom three survived into adulthood.

Interesting facts about Knox's attainment of proficiency as an artillery officer were not found in online internet sources, but rather in written sources. Published bios stated that British Army occupying Boston would hold artillery drills on the Dorchester Neck, firing into the Bay. Henry would frequent the drills, providing officers with the contents of a bottle of Madera, while questioning why certain procedures were being followed. As many of the officers were customers at his bookstore, and as he was a Colonial Militia Officer, they explained each part of their drill in detail.

Another aspect of the British Officers' relationship with Knox was that they would order military books from him, which he would procure from his London agent. Henry would inquire of the officer as to the importance of a particular volume. Fortified by this knowledge, when the requested book came in, Knox would read it and make copious notes, thus increasing his martial knowledge.

Ships arrived in Boston Harbor every day, so Knox would wait to announce to the officer that his book was available only after another ship arrived and he had thus digested the work. When circumstances made his former friends his enemies, it was, ironically, they who had provided the military education that made him a formidably competent Commander.

The importance of Knox's bookstore as a social networking site cannot be overemphasized. Nathaniel Greene, a visitor from Rhode Island who would frequent Henry's shop when he was in Boston became a lifelong friend, as they shared in their quest to become militarily proficient. An indication of Knox's worth to Washington and the Revolution is best noted in a conversation between General Nathaniel Greene and Washington after Greene was appointed Commanding General of the Department of the South, following the disastrous defeat of General Horatio Gates in August 1780. Washington understood the importance of keeping the Southern Colonies in the War on the American side. He told Greene that if it was in his power to assist him in any way, he would endeavor to meet the request. Greene said, "Can I have Henry?" To which Washington replied, "I'd give you my left arm before I gave you Henry."

Knox was at Washington's side directing the Continental Artillery in every major battle. Though Greene was defeated in numerous minor engagements with the British Army commanded by General Lord Charles Cornwallis, he kept the Southern Army together and in the field. Despite being technically defeated in the Battle of Gilford Court House, Greene inflicted 2,500 casualties on Cornwallis's Army. His engagements ran the British into exhaustion, and Cornwallis at last took his army to Yorktown, in hopes of at least overcoming resistance in Virginia, thus sustaining the British Southern of the Massachusetts Council of Min-Strategy. Cornwallis was ordered by his ute Men & Militia, at the US Coast superior Lt. General Sir Henry Clinton, Guard Station in Boston's North End

at Yorktown, so that he could be resupplied, and if necessary evacuated. The French fleet under command of Admiral Conte de Grasse, put the cork in the bottle and trapped the British garrison in position.

Henry oversaw the placement of the Continental Artillery and moved it ever closer to Cornwallis's forces after British redoubts 9 and 10 were taken by American and French assaults. Cornwallis surrendered on Oct. 19, 1781. The Treaty of Paris was signed on Sept. 3, 1783, with Great Britain recognizing the sovereignty of the United States. In due time, Knox, having been promoted to Major General following Yorktown (the youngest such in the American Army during the Revolution), succeeded Washington as Commander in Chief of the ever shrinking Continental Army when Washington resigned his commission. In relatively short order, under both the governing Articles of Confederation and the Constitution, Knox was appointed to the office of Secretary of War. In that office, after the adoption of the US Constitution, as a result of the conflict between France and Britain that began in 1793, the French Revolution, and of piracy on the high seas, he initially oversaw the construction of a reconstituted United States Navy, building six frigates: the USS United States, Constellation, Constitution, Congress, Chesapeake, and President, which were launched between 1797 and 1800. Knox resigned as Secretary of War in 1795 and moved with Lucy to Thomaston, Maine, where he is buried in the Village Cemetery, and his relocated mansion is now a much visited museum

Knox touched many lives during his service to the nation and continues to do so even 275 years after his birth. Americans descended from soldiers of the Revolution, should become cognizant of whether their ancestors had even the slightest connection while Knox served. I, Harry Orcutt, for instance, know that all three of my presently known Revolutionary War soldier ancestors, Moses Church, Jacob Karner, and Peter Orcutt, were at Egremont and Great Barrington, and would have observed with their families the Noble Train of Artillery as it entered Massachusetts on its way to Boston. When Old Ironsides sailed under its own power for the first time since 1881, after being reconstructed in celebration of its 200th birthday, on July 21, 1997, I commanded the Colonial Artillery in New York, to build a deep water port to respond to Constitution's Cannon-

Having been apprised of the protocol, ascending the gangplank, I encountered the executive officer. Raising my tricorn in the Revolutionary War manner of saluting, I requested, "Permission to come aboard, Sir." To which he responded, "Welcome aboard General." I then saluted the nation's colors on the stern, and boarded the vessel for a most enjoyable excur-

In 2000, I again commanded the Colonial Artillery in General John Thomas Park, atop Dorchester Heights, in commemoration of the placement of cannon Knox brought from Fort Ticonderoga, into prefabricated fortifications erected on the night of March 4, 1776, by order of General Washington. I strongly encourage anyone who can trace the family history of either parent in America back at least four generations to research how much further back that family connection may go. 





Local Veterans Tour Nation's Capital Courtesy of Honor Flight Maine

D.C., the veterans on Honor Flight Maine were given a hero's welcome at the Portland International Jetport when they arrived home on Sunday, Sept. 7. The returning veterans were honored with a parade and greeted by enthusiastic family members, friends, and strangers who were there to thank them for their service and welcome them home.

The returning veterans Sept. 7 included four local men. Vietnam-era veterans William Cossette, of Wiscasset, and Bruce Poland, of Bremen, were accompanied by Cliff Hendricks and Ralph Eugley as their guardians, respectively.

During a group interview following the trip, the four veterans made it very clear it was a trip of a lifetime for each of them. Cossette and Poland both served during the Vietnam War, which was very unpopular in the United States at the time, and veterans were often not welcomed

"This was the welcome home we never got" Cossette said. "There were times during the trip that I had 'Honor Flight allergies."

"Honor Flight allergies" is a phase used by Honor Flight veterans and refers to tears filling their eyes in appreciation for recognition they are being given.

"It was once-in-a-lifetime trip for me," Poland said. "It is a trip that I will never forget, or one I would never have made, if it were not for Honor Flight Maine. It was emotional, sometimes overwhelming, and it was filled with appreciation with the outpouring of support from so many. We were treated like heroes from the time we arrived in Portland on Friday morning until we arrived home Sunday afternoon."

Cossette and Poland are members of the Bradford-Sortwell-Wright American Legion Post in Wiscasset. A third member of the Post, U.S. Navy veteran Waldo "Wally" Pitcher was scheduled to go on the same Honor Flight with them but he passed away Aug. 26, 10 days before the flight.

Cassette said he and Pitcher, a longtime friend, signed up together to go on an Honor Flight while attending the American Legion National Convention in June and they were both looking forward to going. Among the items Cossette took with him to Washington was a photo of Pitcher that he carried with him.

Asked what the highlight of the trip was, the veterans said everything was outstanding and wonderful.

The trip began early Friday, Sept. 5 with a Scottish band send off at the Portland Jetport. Honor Flight Maine flew into the Baltimore/Washington International resulted in six small planes transporting

The veterans visited eight stops on Saturday, taking in the Marine Corps War Memorial, Air Force Memorial, Navy Memorial, Military Women's Memorial, Vietnam Veterans Memorial, and the Korean War Veterans Memorial.

> The veterans also attended the changing of the guard at the Tomb of the Unknown Soldier in Arlington National Cemetery.

> According to Cossette, visiting the Vietnam Memorial and the changing of the guard ceremony were emotional moments for him.

> "I could not believe the silence at the ceremony with so many people there," he said. "It is a very special place," he said.

> Poland agreed the changing of the guard is a very special ceremony, but said the Vietnam Memorial was the most impressive to him.

> 'You look at the wall, and there are names of those who gave their lives in that war," he said. "It is not just numbers."


